- WHAT: On Monday, August 24, 2020, the City Council will consider a temporary lane closure along westbound Washington Boulevard between La Cienega Avenue and La Cienega Boulevard and a temporary street closure on Hargis Street between Washington Boulevard and the alleyway to provide area for expanded outdoor dining and services to support businesses during the COVID-19 pandemic.

## How to Submit a Written Public Comment Prior to a Meeting:

The City Council shall consider all oral statements or written communication made or filed by any interested person. Persons who are unable to attend the meeting but wish to submit written comments may do so by any of the following means before **3:00 PM** on Monday, August 24, 2020.

If you wish to make a live public comment during a meeting you will need to join the meeting via the Webex video conference.

There are two ways in which to speak on an agenda item during the meeting:

1. Advance Registration: When registering for the meeting you can identify the agenda item on which you wish to speak.

2. Registration after the Start of the Meeting: You can indicate you wish to speak on a particular agenda item after the start of the meeting.

If you have no way to join via internet, you may join the meeting by calling on your phone. For this option, you will need to contact the City Clerk's Office and provide your name, phone number and the Agenda Item about which you wish to speak so that we can find you and allow you to talk. This option does not allow for you to view the meeting. You may watch via cable or online but please remember to mute the tv or computer so that there is no echo when you speak.
