PRCSC - Discussion of the Park Prohibitions Signage in Culver City Parks and the Removal and/or Replacement of Existing Signs.

Corey Lakin, Parks, Recreation and Community Services Director, provided a summary of the material of record.

Chair Amezola invited public comment.

Patricia Mooney, Senior Management Analyst, read public submitted by:

Disa Lindgren: expressed concern with signage in Spanish prohibiting adult soccer in the parks; she felt that a particular group of community members was being targeted to let them know that they are not welcome; discussed the many people who enjoy the parks; many languages spoken; signage in the City; concern that Spanish is being used to convey a rebuke rather than to communicate respect and appreciation; diversity; exclusivity; and she recommended that the existing signs be removed immediately.

Noah Zatz: asserted that the signage was blatantly racist and should be removed; stated that the only sign targeting the specific population is a sign of exclusion; discussed selective targeting of soccer; non-Latinx adults playing football at Lindberg Park without incident but similar turf impacts; concern with targeting a sport associated with the Latinx community; and universal translation of public signage.

The following member of the public addressed the Commission:

Carlos Valverde discussed members of the community offended by signage in Culver City parks prohibiting adult soccer in one additional language other than English; the cultural significance of soccer; the importance of listening; providing more opportunity for communities of color to shape the laws of the City; actions put into place to keep certain people out; the history of the City; racial covenants; the controversial nature of the signs over many years; discrimination; exclusion; racism; the need to acknowledge that the issue is about more than turf; he asked Commissioners to look at the issue in a wider context; and he suggested banning cleats rather than people.

Discussion ensued between staff and Commissioners regarding length of time that the Spanish language has been covered up on the signage; replacement with consistent signage; listing other sports that are not allowed; adult vs. youth soccer; the way people act on sports fields and the neighbors; history of the item; actions taken; implementation of changes; damage in the park; trouble in the neighborhood; the City Council decision to ban play in the park; the extension of the ban to all parks; group sports covered in the municipal code; subcommittee review of the code; damage done to the fields by adult sports; upgrades necessary to accommodate adult sports; signage as a useful tool to manage what is going on in the park; difficulties with getting people to follow the rules even with signage; support for prohibition of adult team sports in non-designated areas; review of the municipal code by the City Attorney's Office; fair and consistent enforcement; universal signage replacement in English and Spanish as the primary languages spoken in the City; support for review of signage; recommendations of the Turf Consultant; appreciation to the public for sharing concerns; frequency of tape replacement on the signs; reasoning for separate signage; a suggestion that one of the signs be removed; making it clear that propelling

an object is not allowed; signage to address the most violated actions; parks that have the municipal code signage posted twice; concern with wasting staff time replacing tape on redundant signs; other sports being played in the parks; the number one cause of damage on the grass; solving the problem of allowing adults to play and providing a healthy community; the need for inclusivity; the need to face issues and stop deferring; putting money into turf; the pandemic; the inability to take down signage at Culver West Park due to the City Council mandate; a suggestion to create a plan for implementation with a subcommittee to move forward; including the Turf Consultant Report in the discussion; establishing a process for creating multi-level play in the parks; concern with the length of the process; the need to remove signs; determining which parks can be allocated to adult play; concern with taking signs down before a clear plan has been formulated; the report indicating that none of the fields are currently able to support adult play; rehabilitating the fields; making it clear as to what is prohibited and what is allowed; acknowledging that if adult soccer is allowed at a specific park, that park will be dirt; Reimagine Culver City; projects that the City will reallocate funding towards; the fact that the item was previously voted on; the responsibility to inform the City Council that a \$50,000 Turf Report was done; making green space available to people of all ages; consideration of synthetic turf; focusing on where and how the parks can be accessible to all people; and the responsibility to advise the City Council on how to strengthen the parks.

For the purposes of discussion, Commissioner Zeidman proposed a motion to recommend that the City Council remove all signage that prohibits soccer. Commissioner Rickards seconded the motion.

MOVED BY COMMISSIONER ZEIDMAN AND SECONDED BY COMMISSIONER RICKARDS THAT THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION RECOMMEND THAT THE CITY COUNCIL REMOVE THE EXISTING SOCCER PROHIBITION SIGNAGE IN CULVER CITY PARKS.
