Amy Webber, Human Resources Analyst, indicated that no public comment had been received.

Amy Webber, Human Resources Analyst, indicated that no correspondence had been received.

Training: Conducting Administrative Hearings and the Role of the Civil Service Commission

Cristina Talley, Talley and Talley Law, summarized the hearing process; noted that the Commission is a pathfinder and decisionmaker; discussed the hearing process; the upcoming appeal of a disciplinary matter; the process; Civil Service Rule 11.14; the role of the Chair; objections; evidence; leeway; decorum; preponderance of evidence; clarification that the City does not have to establish that the rules or policies violated were necessary, fair or appropriate; and application of facts to make decisions.

Discussion ensued between Ms. Talley and Commissioners regarding Commissioner knowledge of rules; application of rules in a discriminatory manner; pre-hearing conference materials; the federal and state constitution; First Amendment Rights; due process; acceptance of the rules as valid; and adherence to the Oath of Office.

Cristina Talley, Talley and Talley Law, discussed closing arguments; deliberation in Closed Session; application of evidence to the rules; credibility of witnesses; truth vs. perception; determining the most accurate version of the situation; different types of evidence; the duty to consider all evidence presented at the hearing; standard of review; burden of proof; the DeNovo Hearing; reasonable evidence to support the decision; and deference to the decisionmaker.

Additional discussion ensued between Ms. Talley and Commissioners regarding trusting that the supervisor was making a decision within the rules to the extent there is credible evidence to support the decision; the inability to put your judgment before the judgment of the supervisor; suitable consequences; the burden to justify imposition of consequences; reasonable progression of discipline; other factors involved; and establishment of reasoning.

Cristina Talley, Talley and Talley Law, discussed grounds to modify or reject the disciplinary action; employee proof for affirmative defenses; interpretation of the rules; ordinary and common meaning; rendering of findings and the written decision; the role of counsel; draft of findings to support Civil Service Commission July 29, 2020 Page 3 of 5 the decision; Commission review; finalization; and presentation of the final decision.

Further discussion ensued between Ms. Talley and Commissioners regarding rules with discretion in their application; past instances; context for the rule; intent of the rule and department policy; vague rules that are susceptible to more than one meaning; cases of first impression; and unchallenged rules.

Cristina Talley, Talley and Talley Law, discussed bias; the potential to be discredited due to a relationship with a witness; the responsibility to disclose a potential bias; and the script provided to the Chair for the beginning of the hearing.

Additional discussion ensued between Ms. Talley and Commissioners regarding whether there would be a visual component to the hearing; actions of Los Angeles county; the importance of being able to see the witnesses and the appellant; support for using live cameras during a formal hearing; replication of a live process remotely; Rule 11.14; the process; scheduling; the Pitchess Motion; procedures for presenting things under seal; and information distributed to Commissioners.
