Member Jones discussed ideas discussed at the recent Economic Recovery Task Force meeting including: focusing on sustainability during recovery; creating a hiring event and a shop local campaign; capping delivery fees to give restaurants relief; establishing a training certification program for COVID prevention; showcasing art installations in empty storefronts; and providing a dedicated page for virtual performances.

Chair Lachman expressed concern with restaurants being squeezed by larger companies and supported establishing fair rules.

Discussion ensued between staff and Committee Members regarding coordination with the Civil Service Commission; award sponsorship; updating the questionnaire; and creating a plan and a timeline for moving forward.

# Items from Committee Members/Staff

Responding to Chair Lachman regarding upcoming items, Erica McAdoo, Procurement & Financial Services Manager, discussed Measure C and Measure CC Reports.

Onyx Jones, Chief Finance Officer, reported that preliminary financials for June would be going before the City Council on September 29 with a copy emailed to Committee Members, and she encouraged Committee Members to email staff with any questions or concerns, or to attend the City Council meeting.

Member Jones felt the FAC should establish a Task Force or Subcommittee to examine better use of additional sales tax already approved by residents to ensure

that basic City services would not have to be curtailed; discussed the issue of defunding, or reimaging the Culver City Police Department; Measure CC; reducing police officers; violating the promise to the voters who approved the higher sales tax; and he suggested having the attorneys look into the idea and agendize the topic for a future meeting.

Discussion ensued between staff and Committee Members regarding upcoming agenda items; waiting to see what transpires; problematic language in the Transfer Tax; the rebuttal argument; the task of the Committee to comment on the structure, not the exact language of the ordinance going before the City Council; encouragement for Members to look at Section 1d allowing City Council amendment of the measure in any way that does not increase the tax rate; a suggestion to withhold approval subject to review of actual language of proposed measures in the future; the ability to change thresholds; authorized uses for the proceeds; the extension of the measure; marketing for the measure; obligations to residents and businesses in Culver City; and the agenda and speakers for the joint meeting between the City and the FAC.
