## Community Announcements by City Council Members/Information Items from Staff

Council Member Lee reminded everyone to take proper precautions and stay hydrated during the hot weather; noted that information about cooling centers was available at ready.lacounty.gov; and he reported he would be participating in a webinar on October 7 put on by standearth.com

Council Member Sahli-Wells pointed out that the City Council meeting had been scheduled on a Tuesday due to the Yom Kippur holiday, noting the conflict with the presidential debate; announced the Third Community Teach-In with the Equity Subcommittee on October 2 with additional information available at culvercity.org; and she indicated that she would be participating in a webinar on October 7 to discuss Culver City's recent vote to phase out oil drilling with more information available at climatecenter.org.

Council Member Small reported participating in a panel with other area cities to discuss outdoor dining programs, and he indicated that additional information was available at urbanlandinstitute.org

Jeremy Green, City Clerk, announced the October 19 deadline for people to register to vote; she indicated that every registered voter with a correct address would receive a vote by mail ballot for delivery starting on October 5; vote by mail ballot requests are accepted until October 27; and she discussed drop off locations for vote by mail ballots and vote centers.

Council Member Sahli-Wells received clarification that the U.S. Census had been extended until October 31 and she encouraged everyone to be counted.

Heba El-Guindy, Mobility and Traffic Engineering Manager, reported that on September 25, the Baldwin Hills Conservancy Board had voted to award Culver City Prop 1 grant funds for enhancements to the Ballona Creek path; she indicated that if awarded, Urban Greening grant funds could diminish the amount of local matching funds required; and she reported on Public Works Department grants received and in process.

#### COVID-19 Update

Manny Cid, Acting Police Chief and Director of the Emergency Operations Center, indicated that COVID numbers continued to trend in a positive direction; discussed the Community Risk Reduction Team; senior living facilities; he encouraged everyone to get flu shots and continue social distancing and wear masks; and he announced a drive through flu shot clinic at Veterans Park on November 12 in conjunction with Los Angeles county.

#### Joint Public Comment - Items Not on the Agenda

Kelli Estes expressed concern with enacting rent control; community outreach; costs; overreliance on social media; and she asserted that the City should use regular mail to alert residents about important decisions that the City is making.

Leah Koch, The Ripped Bodice Bookstore, discussed the Culver City Farmers Market; the fact that neither the City or the Farmers Market are required to obtain approval from surrounding businesses to operate; impacts to surrounding

businesses; lack of oversight; cooperative permitting; identification of a model that works for everyone; she proposed that the market be required to obtain signatures of support from surrounding businesses in Los Angeles and Culver City once per year; she noted the lengthy process to consider moving the market and felt that action should be taken in the meantime; acknowledged that her business is located in Los Angeles; agreed to provide proof of support from Culver City businesses if necessary; and she asserted that City Council action was necessary as staff had repeatedly indicated that they take direction from the City Council.

Jeremy Green, City Clerk, discussed the erroneous appointment to the LAX Advisory Committee made in June during the annual process and indicated that an applicant was present to speak.

Mayor Eriksson invited public comment.

The following member of the public addressed the City Council:

Taria Lewis provided background on herself; discussed her motivation for serving; the need for increased communication; impacts of the airport on the community; interface between the City and the airport; and ensuring that Culver City has a voice in upcoming changes.

Discussion ensued between staff and Council Members regarding support for the incumbent due to the learning curve involved in the process; support for improving communication; and the late application from Mr. Wahlert.

Additional discussion ensued between staff and Council Members regarding resignation of two Disability Advisory Committee (DAC) Members; outreach; options; the process; applicants for the DAC; simplifying the process; whether a full Committee is necessary in order to complete the work; and support for the two applicants.

Ashley Hefner, Current Planning Manager, discussed General Plan Advisory Committee (GPAC) vacancies; City policies; residency requirements; the Municipal Code; eligibility requirement; GPAC Bylaws; the current member moving out of the City but interested in continuing to serve; and past members who were not residents.

Further discussion ensued between staff and Council Members regarding a recent resignation by a Member who was not a resident but was selected due to being a non-profit leader in the community; expertise of the member requesting to stay despite moving out of the City; work with mental health advocacy groups in the City; consideration of a recommendation from the outgoing member; allowing Council Member Lee to replace the appointment; support for allowing the current member moving out of the City to continue to serve; the feeling that non-residents with a strong connection to the City should not be disqualified; Culver City business owners who do not live in town; guidance regarding future appointments; and support for allowing the new Council Members to decide.

MOVED BY VICE MAYOR FISCH, SECONDED BY COUNCIL MEMBER SMALL AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: APPOINT JOHN WAHLERT TO THE LAX AREA ADVISORY COMMITTEE (LAXAAC) FOR A TERM FROM JANUARY-DECEMBER 2021.

Discussion ensued between staff and Council Members regarding which applicant to appoint to serve in the seat with the longer term for the Disability Advisory Committee.

## CC - Presentation of the Fiscal Year (FY) 2019/2020 Unaudited Financial Report for the General Fund

Onyx Jones, Chief Finance Officer, provided a summary of the material of record.

Discussion ensued between staff and Council Members regarding appreciation to staff for their work; Treasury interest rates; upcoming challenges; CalPERS; waiting to see how severe things get; the CARES Act; increased layoffs; impacts to spending; the importance of sales tax revenue; vacant staff positions; strategically putting things back into the budget before anything is added; the forecast; good fiscal management that in а healthy reserve that exceeded requirements; support for not having to fire any staff; lost revenue; Transient Occupancy Tax (TOT); support for moving forward with caution; restaurants; the Outdoor Dining Program; appreciation to the Economic Recovery Task Force for their efforts; cannabis revenue; increased home delivery; the number of agreed upon businesses; active planning for the potential for Prop 15 to pass; useful allocation of funds; pension liabilities; strategic planning; Utility Users Tax (UUT); and potential revenue from streaming.

Jesse Mays, Assistant City Manager, provided a summary of the material of record.

Mayor Eriksson invited public comment.

The following members of the public addressed the City Council:

Mark Salkin provided background on himself; expressed disappointment in the City Council for their actions to implement rent control; discussed people who are not rent burdened; landlords who live on retirement checks; maintenance; COVID; expensive units that have no control on them; the consultants; state rent control; he felt that the City Council had looked at the issue too narrowly and their actions would come back to haunt them; and he felt that money was being taken from landlords and given to others.

Erik Alexander spoke representing The Meadows noting that the rent control ordinance would subsidize rental units for all rentals regardless of income or need; he asserted that standards would suffer as owners scramble to cut costs; discussed money spent by the City to administer the program; shifting cost burdens; equity; risks to owners; fairness; the renovation taking place at The Meadows; actions taken based on an established set of rules; he asserted that the scope of work would not be able to be completed with rent control; discussed pass through provisions; length of time to capture money spent on planned improvements; maintenance; and he asked the City Council not to approve the ordinance and instead to work with landlords toward an equitable and progressive solution.

Meg Sullivan discussed costs to run the rent control program; responsible housing providers; and she asked the City Council to rethink the ordinance and use a progressive approach to actually help people in need.

Kelli Estes discussed omission of the cost estimate; accessibility of information; economics; reasonable return on investment; equity; removal of an incentive to offer affordable housing; paying the market rate if eviction is

necessary; tenants over family; concern with taking input from UCLA professors; she asserted that the action would be overturned in court; and she urged everyone to vote Yes on Measure B.

Dennis Page asserted that the million dollar program would put landlords out of business; discussed the number of people helped vs. the number of people hurt; the state program; time and money spent on the program; encouragement toward homeownership; permanent renting; the Ellis Act; he asked that the voters be allowed to decide; and he encouraged everyone to vote Yes on Measure B.

Adham Refaat thanked the City Council for their hard work; compared the City Council to the current administration, asserting that they were trying to sneak something in at the last moment; felt that rent control was not the right cure for the problem; felt that the action was not progressive; discussed discrimination; division between landlords and tenants; resentment; he asked that the City Council listen to the data indicating that rent control did not work; and he asked the City Council not to enact rent control.

Johanna Gullick provided background on herself; expressed support for tenant rights; discussed rent stabilization; state law; flaws in the ordinance as written; costs of the program; Regional Housing Needs Assessment (RHNA); redevelopment agencies; affordable housing; utilities; the Los Angeles Rent Stabilization Ordinance; proposed a review of the program after one year; and she thanked the City Council for their hard work.

Keith Jones provided background on himself; discussed costs of the program; businesses in the downtown area not paying their fees; landlords who are not receiving rent during the pandemic; elimination of low income and affordable housing; tenants who make six figures, drive expensive cars and are getting a break on rent; and punishing those who have kept their rents low.

Kevin Lachoff expressed disappointment that the Rental Assistance Program (RAP) had not been revitalized and utilized; discussed funding for the RAP; concern with creating ill-will between landlords and tenants; the recommendation for the equity program; creating equity with income qualified rental assistance; the state program; providing flexibility for landlords to maintain their properties; and he asserted

that the City Council had created undue burden.

Kyle Nelson applauded the City Council for standing up for tenants' rights, and he acknowledged more work to be done.

Yasmine-Imani McMorrin provided background on herself; thanked the City Council for supporting renters and showing political courage and will to support vulnerable community members; discussed use of the word equity without an adequate power analysis; concessions made; acknowledged that the ordinance would not solve all issues; noted the need to produce housing and preserve community; and the importance of keeping people in their homes.

Discussion ensued between staff and Council Members regarding rent control in relation to Section 8; establishing fair market rate for relocation assistance; Housing and Urban Development (HUD) payment standards; the BAE study; the vesting period; the Anti-Harassment and Retaliatory Eviction Provisions; landlords who provide utilities; establishing a review period; City Council ability to make future changes to the ordinance in response to input and experience; clarification that a Rent Board had not been considered; program costs; the appeals process; financial hardship; lack of vilification of landlords and incorporation of "Mom and Pop" landlords into the process; lack of successful petitions for financial hardship during the interim period and the potential for increased and successful applications in the future; concern with turning the issue into a partisan one; incorporating opinions of landlords, renters and homeowners into the process; the history of Culver City as an island without rent control surrounded by rent control; doomsday financial predictions; support for expanding rental assistance in the COVID context; the impact of rent control vs. the Rental Assistance Program; clarification that rent control is an anti-displacement program being pursued in concert with other programs and policy objectives; racial equity; relegation of people of color to the rental market; concern with pitting people against one another; the feeling that rent control is long overdue, but not a solution to curing racial inequities; public input; those afraid to speak up for fear of being put in harm's way financially; reasons for implementing rent control; other cities looking at rent control; the state provision; recognition of differences in rental markets and the allowance for stronger rent control provisions; negative consequences for renters who spoke up in 2015; changes for landlords; the City as an outlier before rent control was

begun; encouraging compliance with a streamlined process; providing stability and predictability; changes made as a result of conversations with stakeholders; local data; outreach; the comprehensive process; the Tenant Protection Ordinance; relocation during the unprecedented time and shortage of housing; acknowledgement that no single strategy would address the housing crisis; additional consideration; the potential for repeal; the upcoming election; the process; concern with the ultimate negative effect on affordable units in the City; comments made by smaller landlords; putting the money from rent control toward all the applicants to the Emergency Rental Assistance Program; and agreement to wait for the next City Council to discuss the Ellis Act.

Additional discussion ensued between staff and Council Members regarding ensuring that the process is as easy to navigate as possible and that there is a focus on providing an appeal opportunity for those experiencing difficulty, and appreciation to staff for their efforts.
