## THE CITY:

Culver City is a Charter City incorporated in 1917, and is a destination filled with outdoor cafes, unique shops and galleries opening onto pedestrian-friendly boulevards. Culver City has a dedicated staff of approximately 700+ employees with an overall operating budget of over \$200 million. The City provides a full range of municipal services including Fire, Police, Community Development, Public Works, Parks, Recreation, and Community Services, and Transportation.

### THE POSITION:

The following tasks are typical for the positions assigned to this classification. Any single position may not perform all of these tasks, and/or may perform similar related tasks not listed here.

Positions assigned to the Public Works Department:

- Assists in repairing asphalt failures by cleaning and filling potholes or cracks using hand tools such as a shovel or rake and power tools such as pavement breakers.
- Assists in sealing cracks in asphalt pavement streets.
- Assists in repairing and replacing concrete sidewalks and curbs including the construction of forms and rodding, tamping and finishing the concrete.
- Performs graffiti removal using a variety of equipment such as ladders, pressure washers, paint brushes/rollers, and airless sprayers.
- Assists in the cleanup of fallen tree branches and other tree related emergencies.
- Assists in the cleanup and mitigation of sanitary sewer overflows and other wastewater maintenance emergencies.
- Assists with weed removal in the public right of way including traffic medians, sidewalks, alleyways and bike paths.
- Performs related duties as assigned.

Positions assigned to the Parks, Recreation and Community Services Department:

- Assists in turf maintenance in City parks and landscaped areas using lawnmowers, power edgers, and other tools.
- Assists in checking sprinkler heads for proper functioning. Cleans and adjusts heads as necessary. Reports problems to Supervisor.
- Assists in the planting of flowers in planters, medians, and other landscaped areas.
- Assists in controlling the growth of weeds in lawn areas, shrub beds, and flower beds using hand tools and weed eaters.

- Assists in picking up and disposing of trash and debris from roadsides, parks, and other areas.
- Under close supervision, operates a variety of power tools such as, chain saws, hedge trimmers, weed eaters, pruning shears and leaf blowers.
- Operates a pick-up truck.
- Performs related duties as assigned.

Positions assigned to the Transportation Department:

- Routinely inspects and cleans facilities, bus stops (including shelters, benches, trashcans and signs). Reports and problems to immediate supervisor.
- Assists with the maintenance of facilities, bus stop shelters and related equipment, such as benches and trashcans using hand and power tools.
- Assists in repairing and replacing of new bus stop poles, signs, LED displays, shelters and related property. Reports any customer complaints to appropriate staff.
- Under close supervision, operates a variety of power tools, secures equipment, and reports any problem with equipment to immediate supervisor.
- Performs graffiti removal at bus stop shelters, trash receptacles, and surrounding sidewalk areas using a variety of equipment such as ladders, pressure washers, paint brushes/rollers and airless sprayers.
- Assists in the maintenance and repair of shelters which includes drilling and breaking concreate and/or asphalt for the purpose of removing poles and related property.
- Changes bulbs such as fluorescent and LED lights.
- Performs related duties as assigned.

#### Training and Experience:

Any combination equivalent to training and experience that could likely provide the required knowledge, skills and abilities would be qualifying. A typical way to obtain the knowledge, skills and abilities would be: six months experience in the use of hand and power tools and performing manual labor for lengthy and continuous periods of time.

#### Licenses and Certificates:

Possession of a valid California Class C driver's license at the time of the examination.

#### **EXAMINATION PROCEDURES:**

Applicants must receive a passing score on the following examination components in order to be placed on the eligible list. **Please note**: There is a six (6) month waiting period to re-test; therefore, applicants who have participated in the examination process within the preceding six (6) months will be deferred and will need to re-apply after the six (6) month waiting period.

#### **COMPONENTS**

**Performance Test (weighed at 40%):** To measure ability and skill in performing heavy manual labor and to measure knowledge of tools used in the (Tentatively scheduled for the week of January 25, 2021).

**Appraisal Interview (weighed at 60%):** To evaluate training, experience, training, and personal qualifications. (Tentatively scheduled for the week of February 22, 2021).

Background/ Reference Check: Upon a conditional job offer, a live scan finger printing must be completed with acceptable results. If an applicant is selected as a finalist, he or she will be contacted to schedule a fingerprinting appointment. Upon hire, employee is subject to further reporting from DOJ via subsequent arrest notification.

Pre-placement medical evaluation including drug screen will be required.

E-Verify: Proof of U.S. citizenship, alien residency or authorization to work in the U.S. will be required at time of appointment.
