CAC - Consideration of a Permanent Entry Canopy Concept by Luna Ikuta Toward Fulfillment of the City's Art in Public Places Program Requirement for a Development Project at 11924 Washington Boulevard (Haven)

Christine Byers, Cultural Affairs Coordinator, introduced the item and provided a summary of the material of record.

Adam Perry, CityView, developer of the Haven project, noted difficulties for retailers in 2020 and expressed eagerness to bring the art installation to the project and to the community.

Beau Basse, LeBasse Projects, project art consultant, provided background on the Haven project; presented images of the location; discussed entitlements for a canopy at the entrance of the building; and the Art in Public Places Program requirement.

Luna Ikuta, artist, introduced herself; provided examples of her past work; discussed her background and experience; the pandemic; connecting with the natural world and taking inspiration from nature; she presented renderings of the proposed artwork; discussed the fabrication process; materials used; angles; colors; textures; the intention to create a new work for the Culver City public art portfolio; and she thanked the Subcommittee for their assistance in the process.

Beau Basse, LeBasse Projects, indicated that this would be the first permanent public art installation for Luna Ikuta.

Christine Byers, Cultural Affairs Coordinator, provided a correction to report noting that the canopy would include a total of 19 vertical columns, rather than 14 as noted in the staff report.

Commissioner Pali reported that much work had been done to get the project to the current state, noting that the project met the requirements of the ordinance; he felt that the leaves required additional consideration; discussed the quality of the material, paints and welding joints; ensuring that the welding of each leaf stem to the main branch is cleaner than was the case in the sample provided; commented on what is art and what is craft; work on technical issues; and he felt that the details were pretty worked out and that the project could move forward.

Commissioner Williams reported examining the materials and expressed concern that some of the leaf attachments were bulky; discussed the potential for water damage; and concern that the leaves were easily movable.

Discussion ensued between project representatives, staff and Commissioners regarding the original design; thickness of the

leaves; strength; addressing the lumpiness of the welded connections; ensuring that the piece is best suitable for an outdoor installation; support for the structure's reference to nature; appreciation for the process to improve the design and the responsiveness of the artist; maintenance; conservator review; finalization of materials and vendors; and the required Conservation and Maintenance Plan.

MOVED BY COMMISSIONER WILLIAMS, SECONDED BY CHAIR FLEISCHER AND UNANIMOUSLY CARRIED, THAT THE CULTURAL AFFAIRS COMMISSION: APPROVE A PERMANENT ENTRY CONCEPT BY LUNA IKUTA TOWARD FULFILLMENT OF THE CITY'S ART IN PUBLIC PLACES PROGRAM REQUIREMENT FOR A DEVELOPMENT PROJECT AT 11924 WASHINGTON BOULEVARD (HAVEN).
