Action Items

Receipt and Filing of Look Back Conditions and Summary

Michael Allen, Current Planning Manager, provided a summary of the material of record noting that the permitting system was being used to monitor Look Back Conditions and to initiate ongoing reminders.

Discussion ensued between staff and Commissioners regarding the two Look Back Conditions for Costco; non-compliance with the noise study requirement for Tire Center Operations at Costco; the center median on Washington Boulevard along the project frontage; the Redevelopment Agency Improvement Plans; impacts from Washington to Centinela moving west; community benefit provisions; storm water retention; delays due to other factors; use of recycled stormwater to irrigate the medians; concern with creating unnecessary future work with Look Back Conditions; effectiveness; measuring impacts; reasons for imposing Look Back Conditions; reviewing which outstanding Look Back Conditions are necessary; changing opinions over time; traffic; encouragement to recognize changing conditions; relevance; investing in public

policy to encourage public transit; neighborhood impacts; adding a sunset provision; touring sites once the pandemic is over; Look Back Conditions imposed as part of the deliberation process by the Commission or the City Council; ensuring that things are not carried on longer than is applicable; and staff agreement to vet the list attached to the report and return with draft wording for adding sunset provisions to Look Back Conditions.
