Pledge of Allegiance

Member Bano led the Pledge of Allegiance.

Items from Committee Members

Chair Rona thanked staff for their valuable assistance; discussed her job as Communications Director for a public health agency; focusing on matters of equity; disparities, especially with regard to COVID; the various forms that inequities take; the reminder to consider everything through an equity lens; she thanked Vice Chair Valverde for alerting her to diversitybestpractices.com; discussed the cultural diversity calendar on the site; Purim; harassment of people of Asian descent; the mission of the Committee to serve people of many different backgrounds; and the U.S. census.

Vice Chair Valverde discussed reflecting on world events; moments in history; recognition of March 21 as International Day of Elimination of Racial Discrimination; and Cesar Chavez Day.

Member Bano discussed the Guibord Center in Los Angeles.

Member Moammar discussed Black History month; architect Paul R. Williams; Malcom X; she noted that Vice Mayor Daniel Lee is the first elected African American Council Member to serve in the 100 year history of Culver City; and she acknowledged recently elected Council Member Yasmine-Imani McMorrin as the first African American woman to serve.

Member Morgan provided background on himself; described experiences that inspired him to become an activist and to serve on the Committee; and he discussed the route to equity through Human Relations.

Vice Chair Valverde discussed Prop 187, passed in 1994, but never implemented due to numerous lawsuits.

Member Morgan observed that Prop 187 was the catalyst for the "Brown Wave" or the increase in activism by people of color.

Chair Rona invited public comment.

Dr. Janet Cameron Hoult provided background on herself; discussed her experience seeing Dr. Martin Luther King Jr. speak in 1961; creative student protests; her active participation in the Congress of Racial Equality (CORE); she felt Dr. King's words were ignored when people do not recognize that everyone is equal: and she encouraged everyone to follow Dr. King's words to defeat racial injustice.

Chair Rona discussed Brown Act Rules and procedures for receipt of public comment.

Christina Harley provided background on herself; discussed her participation in the 2012 Dr. Martin Luther King Jr. Celebration; her play celebrating the legacy of Dr. Martin Luther King Jr.; the focus on inclusivity; and she read an excerpt from the play.

Shannon Theus shared a poem by Chair Rona that she read at the last Democratic Club meeting called: "Let My People Breathe."

Will Rickards provided background on himself; discussed upcoming holidays; the Bahá'í Faith; the Bahá'í calendar; upcoming celebrations; he expressed interest in collaborating with other groups in the City on projects of service; and he indicated that he would return at the next meeting with formal invitations to upcoming activities.

Chair Rona discussed agendizing presentations to share with the community and allowing the community to share with the Committee.

Chair Rona introduced the item.

Lisa Vidra, Senior Deputy City Attorney, received clarification regarding the composition of the subcommittee.

Member Bano indicated that she and Members Moammar, Grimes, and Vice Chair Valverde had met as the Partnerships, Education and Public Outreach Ad Hoc Subcommittee to brainstorm ideas; she discussed the focus on events and effective communication; bringing people together rather than dividing them; types of events; identified topics of interest based on survey and subcommittee input; addressing topics in an intersectional manner; and including young people in the events.

Member Moammar clarified that Saint Joseph's Center addresses homeless issues, not mental health issues.

Subcommittee Members read the different event types identified by the Ad Hoc Subcommittee and suggested timelines.

Discussion ensued between staff and Committee Members regarding creation of a City walking tour guide book for users of all ages; providing the history of various areas in the City; ranches that used to exist in Culver City; and the potential for creation of a documentary about Culver City.

Chair Rona invited public input.

The following member of the public addressed the Committee:

Dr. Leah Pressman provided background on herself; discussed the Talk Project; POC for Change; collaboration with the Culver City Unified School District (CCUSD); she proposed an event to highlight a book by Kenneth Paul Rosenberg that about issues within the mental health system; discussed Surgeon General, Nadine Burke Harris; Adverse Childhood Experiences (ACEs); events connected with Steve Silberman and his book, NeuroTribes; collaboration with the Wende Museum; suicide awareness; and programming through Erika's Lighthouse.

Discussion ensued between staff and Committee Members regarding support for the historical markers and walking tour concept; the Historical Society; City Historian Julie Lugo Cerra; ethnic and cultural history of Culver City; a suggestion to have a guest share a bit of City history before concerts at the Summer Concert series; establishing priorities; the story telling event; holding a speaker event in April; holding an event to mark Juneteenth; working with

the Committee on Homelessness to do a joint event in the context of the Speaker Series; communication between the two Committees; holding a joint public meeting; Brown Act Rules; resources included in the Work Plan; types of subcommittees; ability of members of the public and other Committees to attend; clarification that EHRAC Members can attend meetings as a member of the public, but cannot speak representing the EHRAC; a suggestion to have an event in the future with Saint Joseph's to raise awareness about homeless issues; suggestion to have topics align with recognition months; a suggestion to have a speaker address hate crimes; ensuring that similar topics are spread out; creation of an ad hoc subcommittee to discuss an event with a representative from the County of Los Angeles Human Relations Commission to present data on hate crimes in Culver City; concern that hate crimes is a heavier topic than was intended for the speaker series; the intent to educate about hate crimes and hate incidents; the speaker series vs. presentations; a suggestion to hold a symposium on hate crimes; the intent to hold several events before the end of the fiscal year; establishing general parameters for the events; empowering the existing subcommittee to move forward with the help of staff; creating a separate subcommittee for each event; the feeling that Juneteenth should not be a part of speaker series; and whether to have a separate subcommittee for each event.

Chair Rona proposed a motion to establish two ad hoc subcommittees to deal with two events, each to occur during this fiscal year, one related to hate crime, and the other to celebrate Juneteenth. Member Bano seconded the motion and the discussion continued.

Vice Chair Valverde suggested that one of the proposed subcommittees work on hate crimes and investigate finding a speaker on homelessness, and the other subcommittee address the Juneteenth event.

Chair Rona revised her motion to create an ad hoc subcommittee charged with establishing one event on homelessness and one on hate crime with a report brought back to the EHRAC, and another ad hoc subcommittee created and charged with establishing and presenting recommendations on the creation of a Juneteenth event.

Additional discussion ensued between staff and Committee Members regarding timing for the homelessness event; a

suggestion to have less subcommittees; the importance of doing quality work; ensuring that people are not spread too thin; and allowing everyone a chance to contribute.

Member McBride proposed a substitute motion to appoint an ad hoc subcommittee to identify two events and to focus on implementing them.

Discussion ensued between staff and Committee Members regarding procedures for motions, amendments and substitute motions.

Member Di Vincente seconded Member McBride's motion.

Chair Rona introduced the item.

Vice Chair Valverde summarized the material of record; discussed suggestions to improve the EHRAC website page; encouraging communication with staff, volunteers and Committee Members; providing multiple versions of the complaint forms; accessibility; recommendations on the complaint form; allowing an opportunity to make a complaint without providing identifying information; incomplete complaint forms; and recommended changes to the complaint form.

Discussion ensued between staff and Committee Members regarding support for increasing a welcoming environment on the main page by providing pictures of Members along with their bio and contact information; providing a Spanish language website; support for having a welcome video in multiple languages; current availability of the majority of the website in Spanish; keeping all City webpages uniform; another City body that sought to provide bios on their webpage; allowing ease of contact; reliability of translation apps; providing multiple versions of the complaint forms; tracking for follow-up; the charge of the Committee to track trends; complaint resolution; status of incomplete forms; complaints received to date; the process for handling complaint forms; information currently required on the forms; and staff agreement to return with information on the complaint handling process.

Chair Rona moved to create an ad hoc subcommittee to focus on creation of an anonymous public complaint form and Member Bano seconded the motion.

Additional discussion ensued between staff and Committee Members regarding confusion created by offering multiple forms; a suggestion to have one form with the option to disclose identity or not; the difficulty of conducting a

thorough investigation and following-up on anonymous complaints; indicating on the form that it would be helpful for follow-up and investigative purposes if the complaint was not anonymous; and making it clear that complaints would be addressed confidentially.

Chair Rona withdrew her original motion and proposed a substitute motion to form an ad hoc subcommittee to create an anonymous survey on the webpage to identify concerns. Member Moammar seconded the motion.

Additional discussion ensued between staff and Committee Members regarding clarification on the work required of the subcommittee and goals of the survey; the intent to receive feedback on events and identify trends and/or issues surfacing in the City; whether creation of a monthly action item to receive information on survey forms and submitted complaints is necessary; and making revisions to the complaint form.
