Greeting and Visit by Los Angeles County District Number 2 Supervisor Holly Mitchell

Supervisor Holly Mitchell congratulated Council Members Vera and McMorrin on their election to serve on the City Council; she commended the City on their partnership with holding a vaccine clinic; she indicated willingness to partner with Culver City; discussed the American Rescue Plan; the pandemic; and she emphasized her commitment to cities in the Second District.

Kelli Estes stated that she was aware of what the county had planned for reopening but was unaware of what the City would be doing.

Sebastian Hernandez, Culver City Action Network (CCAN), discussed the slow pace of the Public Safety Review; the number of police employees; enactment of a hiring freeze; concern with posted jobs; the recommendation by the Solidarity Consulting Report, backed by the Center for Public Safety Management Report; the delay in implementing the mobile crisis unit; and he wanted to see progress moving forward more rapidly.

Rebecca Rona-Tuttle, Equity Human Relations Advisory Committee (EHRAC) Chair, discussed items to be considered at the upcoming EHRAC meeting; the Racial and Equity Action Plan; upcoming events; and she encouraged everyone to participate in the March 23 EHRAC meeting.

Colin Diaz discussed items on the agenda and meeting length; limiting comments from Council Members to five minutes; and the importance of showing collaboration with the community and ensuring efficiency.

Mark Lipman discussed the proposed Direct Housing Pilot Program; addressing wraparound services; the recent Committee on Homelessness meeting; reports from Upward Bound House and Saint Joseph Center; and clarification that if the City provided the rent portion of the Direct Housing Program, Saint Joseph has indicated they would be able to absorb the wraparound services.

Council Member McMorrin discussed the mass shooting in Atlanta noting that she was standing in solidarity with the Asian community; she expressed hope that the world was working to change; and stated that she was praying for everyone impacted by senseless gun violence.

Council Member Vera asserted that there was no room for hate.

Council Member Eriksson expressed concern with recent shootings.

Vice Mayor Lee observed that the more the world gets back to normal, the more people get back to being their worst selves; he wanted to see effort to make substantive changes; and he noted many countries that do not have frequent mass shootings also do not have strong gun control policies.

Mayor Fisch commented that recent events were the most visible part of a wave of violence against Asian and Pacific Islanders; discussed the commitment of the City to protect the safety and rights of residents; continued work; and the need to live up to declarations.

Punit Chokshi, Senior Management Analyst, discussed the Internal Audit Division Framework.

Discussion ensued between staff and Council Members regarding appreciation to staff for their efforts; outreach; statistics for calls received by the Hotline; the process for reporting; quarterly reporting summaries; lack of activity; educating the public about what is available; encouragement for employees to

make use of the resource; and increasing the focus on the waste aspect in the future.

Mayor Fisch invited public comment.

Jeremy Green, City Clerk, indicated that no public comment had been received.

Sol Blumenfeld, Community Development Director, introduced the item.

John Kaliski, Kaliski and Associates, reported being hired to provide a feasibility study for adaptive reuse of existing hotel/motel sites in Culver City for affordable housing; he described the process; and he discussed identified candidates.

Sol Blumenfeld, Community Development Director, indicated that staff was looking for guidance on the purchase of sites for a shelter or for permanent supportive housing; he discussed site size; communication with property owners; the process for moving forward; operating costs; collaboration with the county; and the limited budget.

John Nachbar, City Manager, discussed federal funding; earmarks; and the deadline.

Discussion ensued between staff and Council Members regarding one-time funding; the process moving forward; property cost; and appreciation to staff for their efforts.

Mayor Fisch invited public comment.

The following members of the public addressed the City Council:

Khin Khin Gyi, provided background on herself; expressed support for the recommendation from the consultants; discussed potential housing types; locations; and she asked the City to contact the Governor's Office to get information about available state-owned land for affordable housing.

Karlo Silbiger provided background on himself; expressed support for the item; discussed consideration of whether the facility would be a shelter or permanent supportive housing; fitting within the larger context of how homelessness is being addressed in the community; other housing opportunities; ensuring that properties are used in the most impactful way; outreach to neighbors; and spreading out affordable housing in all parts of the community.

Darryl Cherness wanted to see concrete action to place the homeless in housing; expressed support for exploring the feasibility of various proposals including hotel reuse for homeless housing, modular housing, shelter construction at specific locations, construction of modular units at the Community Garden, and the Accessory Dwelling Unit (ADU) incentive program; discussed promoting community support; security; the moral obligation to help the homeless in Culver City; and the right of everyone to be treated with dignity and to have basic shelter.

Bubba Fish provided background on himself; expressed support for the item; wanted to see people get off the street; discussed the goal of permanent supportive housing; root causes; parking requirements; free public transit; safe parking; elimination of R-1 zoning; and the importance of increased housing supply.

Mark Lipman discussed other recommendations from the Committee on Homelessness; the Safe Parking Program; the ADU program; clearly defining what is considered workforce housing; the Direct Housing Pilot Program; the importance of taking a bottom-up approach; making important changes immediately; those who participate in re-housing programs that are moved out of the City; the Housing Locater app for Saint Joseph; being welcoming

to those who make a lot of money, but not for those with the least amount of money; and the importance of housing people in the community now instead of waiting for future options.

Judi Sherman discussed creativity being used to address issues; repurposing empty office spaces; she thanked staff for their efforts; and she wanted the Safe Parking Program to be implemented soon.

Ron Bassilian, Protect Culver City, asserted that Sepulveda was being turned into a homeless corridor; stated that local residents were being terrorized by the homeless with certain streets not being walkable anymore; and he indicated being in touch with residents in the area.

Discussion ensued between staff and Council Members regarding partnering with the county and non-profit organizations; making use of a hybrid model; the Housing First Model; providing a service center for those who have not been connected to housing; modular housing; implicit support from Supervisor Mitchell's Office; county support; earmarks; and allocations.

Sol Blumenfeld, Community Development Director, discussed the Venice parking lot; collaboration with Paul Koretz; costs; the number of potential modular units vs. shelter beds; and the need for Council direction in order to proceed.

Additional discussion ensued between staff and Council Members regarding discretion to proceed expeditiously with either modular units or a shelter at the Venice parking lot site; the need for a strong partnership with Los Angeles in order to proceed; clarification that Culver City owns the Venice parking lot; costs; concern with potential difficulties coordinating with Los Angeles; the importance of gaging interest; support for moving forward with locations that the City can control completely; changes since the start of the pandemic; counterproposals put forth in 2019; support for permanent supportive housing over shelters; the commercial component; creating a connection to job training or a job that will hire someone who has been unhoused for many years; motel reuse; feasibility with hotel/motel reuse; addressing resident concerns; a suggestion that the Mayor contact Paul Koretz's office for exploratory meetings; service providers for permanent supportive housing; and Culver Palms United Methodist Church.

Sol Blumenfeld, Community Development Director, discussed the Virginia lot; potential uses; Sprung shelters; and the need for direction from the City Council.

Discussion ensued between staff and Council Members regarding a potential partnership with an affordable housing developer; potential lease issues; developer interest in the property; current usage of Sprung shelters; safety concerns; pallet shelters; support for providing transitional housing; site limitations; site planning; feasibility; costs; identifying collaborators; safety and security; looking at sturdy, longterm housing for the larger site; utilizing the space to house as many people as possible; prioritizing rapid response housing where people are now; identification of a partner development; dangers associated with shelters; looking for more permanent solutions; providing safe, below market housing on the Virginia lot; outstanding leases; length of time accomplish a large project; repurposing a portion of the site for another use in the meantime; complications for businesses in the area; problems that will arise once things move forward; renegotiation of leases; and the actions of Redondo Beach to create facilities.

Sol Blumenfeld, Community Development Director, discussed the Methodist Church project and creation of extremely low to moderate affordable housing units.

Additional discussion ensued between staff and Council Members regarding meeting Regional Housing Needs Assessment (RHNA) goals; partnerships; staff impact; gap funding; and City Council consensus to support a potential text amendment to grant ministerial approval for certain projects up to 20 units.

Tevis Barnes, Housing Programs Administrator, indicated the need for guidance regarding extending the Rental Assistance Program (RAP) with unexpended funds; 79 households approved to participate; other Housing Authority programs; whether to have another application process; modification to program guidelines; areas of concern during the vetting process; the requirement that applicants only receive assistance from one entity; a suggestion that families be allowed to receive assistance from more than one entity as long as they are not concurrent; applicant assets; direct owner payments; owners who refuse to participate in the program; Block Grant funds; the Low to Moderate Income Asset Fund; SB 91; program overlap; and modifications to program guidelines.

Further discussion ensued between staff and Council Members regarding Council consensus to support another round of the Emergency Rental Assistance Program, the staff recommendation guideline changes including non-simultaneous subsidy programs, participation in the asset test, addressing owner refusal to participate in the RAP; cash assets; the architect competition to provide ADU plans; City Council consensus to direct the Planning Commission to consider preprinted ADU plans for the City; and a request to staff to report back on usage of the COVID Rental Assistance Program with excess funds to be put back in to the City ADU program.

CC - (1) Consideration of Adoption of Alternate Proposed Resolutions Establishing Guiding Principles for Culver City's 2021-2029 Housing Element Update; and (2) (If Desired) Adoption of the Proposed Resolution of Choice

Ashley Hefner Hoang, Advance Planning Manager, provided a summary of the material of record.

Eric Yurkovich, Raimi and Associates, provided a brief presentation on the Housing Element; discussed relating the Housing Element to other Elements in the General Plan; key components; shifting policy context around housing in California; RHNA; the Housing Element Sites Inventory Analysis; the recommended buffer; housing needs over the General Plan time horizon; the broader General Plan; General Plan Land Use Alternatives; the preferred land use map; California Environmental Quality Act (CEQA) impacts; mapping out housing programs for Culver City; and the potential need to update City zoning.

Discussion ensued between staff and Council Members regarding the past Housing Element update; the review period; different options available; clarification that the elimination of R-1 zoning is not considered in either option; the Regional Early Action Plan (REAP); the experience of San Diego; support for being a model in the state rather than a defendant in litigation; de-facto triplexes; and changes in the state regarding R-1 zoning.

Mayor Fisch invited public comment.

The following members of the public addressed the City Council:

Kate Ainslie was called to speak but did not respond.

Nancy Barba expressed support for the first version of the Housing Element to encourage housing growth in the community; discussed equal distribution of low-income housing; Opportunity Atlas; the importance of furthering fair housing; future housing production; and previous failure of the City to meet RHNA goals.

Rosi Gabl was called to speak but was not present in the meeting.

Max Gabl was called to speak but was not present in the meeting.

Bubba Fish provided background on himself; expressed support for the proposed resolution; and he discussed benefits of the proposal.

Amy Ellzey expressed opposition to the proposal to move forward with multi-family housing zones in Culver City; felt it was inappropriate to make major changes without large scale resident involvement; she asserted that the changes would attract more expensive construction, increase home prices and drive-up rents resulting in the displacement of people of lesser means; discussed the defeat of SB 50; inferior design; homeless who lobbied against the proposed bill in Marin county; increased vacancies; she noted that the need was not pressing; and she asked the City for their equal representation of residents by not changing the zoning.

Eden Miller expressed support for option one of the proposed resolution as she felt the changes would improve the City and provide equity.

Leah Lee expressed support for the modified resolution in support of affordable, fair and equitable housing distributed

throughout the City; discussed the history of the City; and she felt that the change would make the City an even more idyllic place to live.

Elias Platte-Bermeo, Culver City for More Homes; expressed support for bringing more affordable housing to the City; discussed obstruction of development; the need for a transformative housing element; and planning an accessible affordable City for people of all walks of life and income levels.

Kate Ainslie was called to speak but could not be heard.

Ryan Olson discussed addressing with the housing crisis and he expressed support for the proposed model resolution.

Patrick Meighan, Culver City for More Homes, expressed support for the original proposed model resolution, attachment number one as he felt that restrictions would be reduced; discussed bringing more housing to the City; he felt that R-1 zones should not be maintained; discussed equitable housing; segregated housing construction; and meeting housing goals.

Luanne Chang provided background on herself; she did not want to see Culver City more densely populated than it already is; discussed vacant units; traffic; concern with abolishing R-1 zoning; the fact that full utilization of ADUs has not happened yet; and she expressed concern with inviting a world that would not result in equitable housing, but instead, only benefit developers.

Jared Morgan expressed support for the resolution; discussed reversing obstructionism; equitable housing; increased affordable housing; expansion of the City's housing supply; and becoming a welcoming City for all walks of life.

David Voncannon provided background on himself; expressed support for increasing the housing supply in the City; discussed concern with the specific resolution put forward; determination of site eligibility; the need for additional information; application of principles; the need for public outreach; and the importance of addressing the impacts of increased density.

Allen Lulu was called to speak but did not respond.

Patricia Bijvoet expressed support for the proposed resolution, option 1; discussed much needed housing; and the difficulty of getting housing built.

Ron Bassilian discussed the amount of time available to respond to the item; the e-comment section; effects of the change; comments from Culver City for More Homes representatives; concern with eliminating R-1 zoning; outreach; and he proposed tabling the item pending in-person access to provide feedback.

Shannon Gaulding provided background on herself and expressed support for the proposed housing resolution, attachment 1 to provide more housing, including low-income housing distributed equitably throughout the City.

Kelli Estes indicated that she did not see how the changes would result in affordable housing for everyone; she discussed displacement of current renters; tearing down buildings to build larger developments; zoning changes; areas excluded from the changes; the need for additional public outreach; concern with enacting dramatic changes to the City without extensive resident involvement; and the need for proper public notice using regular mail, not just email notifications before making changes.

James MacGaffey provided background on himself; expressed support for the proposed resolution; and discussed addressing injustice and inequality.

Mark Lipman discussed people concerned that the proposed changes will make small town Culver City a mini-Manhattan; developers vs. people who care about affordable housing and those who have been left out; the failure of the resolution to address affordable housing; premature action proposed; the fact that there has not been a full-housing debate about what the community wants; the Rent Control debate; holding major corporations coming into the City accountable for making housing unaffordable; and he noted that the City was being divided and should be brought together to consider what residents want.

Michelle Weiner provided background on herself; expressed support for the proposed resolution in attachment number 1; discussed fairness; housing location; holding major corporations accountable; failure to address RHNA in the past; the process; the General Plan Committee; and she did not want to see the process stalled.

Johanna Gullick provided background on herself; expressed support for option 1 in the staff report; discussed impactful policies; increased incentives for more density; Housing Element policy; she urged the City to move forward with a site inventory; discussed the need for money to meet the housing goals; the Housing Element Technical Advisory Committee; creative funding; and she asked that City financing options be explored.

Linda T expressed support for the first proposed model resolution noting that the City needed to address issues with a solution distributed equally.

Disa Lindgren provided background on herself; discussed support for the proposed model resolution, without modification; discussed the need for more housing and for policies to address climate change; and making up for the history of racial and economic discrimination in the City.

Zennon Ulyate-Crow provided background on himself; noted the need for more homes; expressed support for the proposed item; discussed the affordability crisis; the climate crisis; the need for a more pro-housing, equitable future; and he wanted to see R-1 zoning changed.

Dr. Kate Ainslie, Culver City for More Homes, expressed support for the resolution; discussed the process; appreciation for the efforts of staff and the consultants; codifying the ideals of Culver City; creating a Mayberry for all; setback limitations; and enhancing the ability to offer affordable housing.

Connor Finney thanked the City Council for their consideration; expressed support for the resolution; and he encouraged the City to consider changes to R-1 zoning.

Discussion ensued between staff and Council Members regarding agreement to hold off on consideration of Item A-3 due to the lateness of the hour; appreciation to staff for their efforts; support for making changes to the community to provide access to affordable housing; the importance of equity; the robust process; climate impacts; continued impacts of the history of the City; privilege; valuing diversity; backing up words with policy; RHNA obligations; concern with nebulous language; outreach and education; the need for additional public input for an item with such a lasting impact; including the entire community in the conversation; a suggestion to involve the Economic Development Subcommittee in the process; the need for transparency; confusion expressed by residents; the long-term

housing conversation, but the newness of the proposal; the importance of ownership opportunities; the need to increase housing; the percentage of residents who work in the City; work being done on the Housing Element to satisfy RHNA numbers; consideration of Culver City in the context of being surrounded by Los Angeles; concern with adopting the resolution as written; the upcoming community workshop on Land Use Alternatives planned for April 29; multiple opportunities to provide input; compliance with state mandates; the role of government; addressing inequities perpetuated by the government; the regional nature of the issue; the need to collaborate with other organizations; instances where Los Angeles has followed the lead of Culver City; alignment of purposes; protecting the health and safety of residents and stakeholders; providing as much housing as possible; the legacy of racist R-1 zoning; issues of class, race and misogyny; the ability of government to perpetrate, exacerbate or remediate issues; vacancy taxes; creating affordable housing; fears based on the perception of renters vs. homeowners; symbiotic vs. parasitic relationships; the historic amount of housing created; changing neighborhoods in the City; realistic site capacity; the housing guide; the probability of redevelopment; the jobs/housing imbalance; concern with potential lawsuits for failure to comply with state law; a suggestion to move forward while working on items 1 and 2 and obtain information about items 8-9; survey data; flexibility with the implementation deadline; meeting the adoption deadline with the existing approach; the opportunity to fine tune items; taking advantage of work being prepared at a regional level; incorporating findings; duplication of efforts; fine-tuning for things specific to Culver City; ADU permit streamlining and production actions; the REAP project; affirmatively furthering fair housing; naturally occurring affordable housing; alternative funding mechanisms and models; the plan to provide as much information to all the westside possible; drafting model of acknowledgement that academics are not planners; and practical constraints.

Additional discussion ensued between staff and Council Members regarding ensuring that constituents are heard and that things are written clearly and made understandable; the need for additional outreach; putting things in simpler terms; ensuring transparency; the Emergency Rental Assistance Program; Feed Culver; acknowledgement of different interests in the City; other opportunities for input from the community; state requirements; the difficulty of simplifying things that are not simple; acknowledging the complexities of housing; overriding

goals; residents who are concerned that things are needlessly complicated; length of the process; and City Council consensus was achieved to handle principles 3, 4, 6 and 7 within the existing scope of work, address principles 1, 2 and 5 in phase 2 after adoption covered by the contingency budget if they cannot be done within the existing scope of work, rely on the Westside Cities Council of Governments project findings for principles 8 and 9, and not include principle 10.

Further discussion ensued between staff and Council Members regarding reporting on the status of the principles; staff agreement to provide the draft element before presentation to HCD; deadlines; the possibility of deferring the work of principles 1 and 2 until services can be cheaper; next steps; the process; the need for the item to come back when A-3 comes back; and City Council consensus that the Planning Commission review the principles.
