1 3. The assessment for improvements as set forth in the Engineer's Report
2 shall be performed pursuant to law. The County Auditor shall enter on the County Assessment
3 Roll the amount of the assessment and the assessment shall be collected at the same time and
4 in the same manner as the County property taxes are collected. After collection by the County,
5 the net amount of the assessment shall be paid to the City of Culver City.

6 4. Upon receipt of monies representing assessments collected by the
7 County, the City shall deposit the monies into a special fund known as the "Fund for Benefit
8 Assessment District West Washington Boulevard No. 1," which was previously established upon
9 the creation of the District.

10 5. Immediately upon the adoption of this Resolution, the City Clerk shall file
11 a certified copy of this Resolution, which includes the Engineer's Report containing the diagram
12 and assessment, with the County Auditor.

13 6. A certified copy of the Engineer's Report shall also be filed in the Office of
14 the City Engineer, with a duplicate copy on file in the Office of the City Clerk, and shall be open
15 for public inspection.
