RESOLUTION NO. 2021-R 1 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF 3 CULVER CITY, CALIFORNIA, APPROVING THE ASSESSMENT ENGINEER'S REPORT, DECLARING ITS INTENTION TO 4 THE ANNUAL LEVY AND COLLECTION ORDER OF ASSESSMENTS FOR THE LANDSCAPING MAINTENANCE 5 ASSESSMENT DISTRICT NO. 1, AND SETTING A TIME AND PLACE FOR A PUBLIC HEARING THEREON. 6 7 WHEREAS, the City Council previously initiated proceedings in accordance with 8 the provisions of Chapter 15.01 of the Culver City Municipal Code ("CCMC") for the levy and 9 collection of annual assessments for the Landscaping Maintenance Assessment District No. 1 10 (the "District") and ordered the preparation of an Assessment Engineer's Report (the 11 "Engineer's Report") thereon; and 12 WHEREAS, the City Council desires to declare its intention to provide for the levy 13 and collection of annual assessments for Fiscal Year 2021-2022, to provide for the costs and 14 expenses necessary to pay for the maintenance and servicing of the improvements (defined 15 below) within the District; and, 16 WHEREAS, the Engineer's Report has been prepared and filed with the City 17 Clerk and submitted to the City Council in accordance with CCMC §§15.01.055 and 15.01.070; 18 19 and. 20 WHEREAS, the City Council has carefully examined and reviewed the 21 Engineer's Report as presented and is preliminarily satisfied with the proposed report, each and 22 all of the budget items and documents as set forth therein and is satisfied that the levy amounts, 23 on a preliminary basis, have been allocated in accordance with the special benefit received from 24 the improvements, operation, maintenance and services within the District as set forth in the 25 Engineer's Report. 26 NOW, THEREFORE, the City Council of the City of Culver City, DOES HEREBY 27 **RESOLVE** as follows: 28 -1-

1. The Engineer's Report as presented, consisting of the following: a 1 description of improvements, the estimated costs of improvements, a diagram of the District and 2 the District assessment roll containing the Fiscal Year 2021-2022 levy for each Assessor's 3 parcel within the District, is hereby approved on a preliminary basis and on file in the Office of 4 the City Clerk as a permanent record and to remain open for public inspection. 5 2. It is the intention of the City Council to levy and collect assessments 6 7 within the District to pay the annual costs and expenses for the maintenance and servicing of 8 the improvements authorized to be maintained and serviced for the fiscal year commencing July 9 1, 2021 and ending June 30, 2022. The improvements are generally described as: landscape 10 maintenance, irrigation, and tree trimming every four years. Services provided include all 11 necessary service, operations, administration and maintenance required to keep the 12 improvements in a healthy, vigorous and satisfactory condition. 13 3. The District is located generally around the perimeter of Studio Estates. 14 The District is designated by the name of "Landscaping Maintenance Assessment District No. 15 1." 16 4. The Engineer's Report, as preliminarily approved by the City Council, is 17 on file with the City Clerk and open for public inspection. Reference is made to the Engineer's 18 Report for a full detailed description of the improvements to be maintained, the boundaries of 19 the District and the proposed assessments upon assessable lots and parcels of land within the 20 District. 21 5. The maximum assessment is not proposed to increase from the previous 22 year. 23 24 6. Notice is hereby given that a Public Hearing is scheduled to be held via 25 video conference on June 28, 2020 at 7:00pm or as soon thereafter as the matter may be 26 heard. Instructions for participating in the meeting will be included in the June 28, 2020 City 27 Council meeting agenda. All interested persons, prior to the conclusion of the hearing, shall be 28 -2-

1	afforded the opportunity to hear and be heard. The City Council shall consider all oral	
2	statements or written communication made or filed by any interested person.	
3	7. The City Clerk is hereby directed to give notice of the Public Hearing by	
4	causing the resolution of intention, or summary thereof, to be published, posted and mailed as	
5	provided in CCMC §15.01.050.
