Ruth Martin del Campo, Administrative Clerk, received clarification from Commissioner Menthe that he could hear the meeting clearly; he had a copy of the agenda for the meeting; a copy of the agenda was posted at his location; there were no members of the public present and wanting to speak at his location; she asked any member of the Commission to speak up if they were not able to hear Commissioner Menthe and no Commissioner indicated that they could not hear Commissioner Menthe, nor did they indicate that there was any reason to doubt that was Commissioner Menthe taking part in the teleconference; and she indicated that all votes would be taken by roll call during the meeting.

**Presentations**

Item P-1

**PC - Presentation: Appreciation of Vice Chair Ed Ogosta and Prior Commissioner David Voncannon for Service on the Planning Commission**

Erika Ramirez, Current Planning Manager, announced that David Voncannon was not able to be present, but Commissioners were encouraged to share any comments which would be recorded and presented to Mr. Voncannon.

Mark Muenzer, Planning and Development Director, discussed accomplishments of Ed Ogosta and expressed appreciation for his service to the City.

Ed Ogosta discussed his appointment to the Commission 8 years ago; the service of Scott Wyant; the kindness of all involved and the privilege of serving; transformative projects in the City; Culver City as a forward-thinking creative hub, well prepared for the 21<sup>st</sup> century; appreciation for the patience of staff and Commissioners on the importance of good architecture and design; the purpose of buildings; weighing decisions against ideals; deciding how they want to live; judging what is good and what isn't good enough; the importance of aiming higher and asking more of buildings and cities; the need for high quality, durable buildings that last and use energy smarter; having policy less shaped by profit and real

estate speculation; being more considerate of the community; he felt that buildings should spark joy; noted that buildings endure through time because they are loved; he hoped to have left an imprint on the Commission; he stated the most rewarding part of the experience was the people; discussed growth through disagreement and discussion; compromise yielding better outcomes; wrestling with tough decisions; overlooked items; appreciation for the intelligence, passion, honor and commitment to the City by Commissioners and staff; he welcomed Commissioner Menthe; and he thanked staff, Commissioners and his wife.

Commissioners thanked Ed Ogosta for his service; felt that his comments rang true; expressed appreciation for other perspectives and things learned from Mr. Ogosta; acknowledged the gravity of decisions made; discussed recent Brown Act training; appreciation for buildings designed by Mr. Ogosta and for insights he brought to the Commission; the feeling that Mr. Ogosta improved each project; appreciation for Mr. Ogosta's welcoming nature; and appreciation for Mr. Ogosta's knowledge of architecture and planning, as well as for his integrity and commitment to the City.

Chair Barba invited public comment.

The following member of the public addressed the Commission:

Dana Sayles, former Planning Commissioner, discussed former Commissioners Scott Wyant and Linda Smith Frost; health challenges faced by David Voncannon; the role of Ed Ogosta on the Commission to ensure that the quality of projects did not suffer and to challenge everyone to do better; the hard work of Ed Ogosta; his focus on the project rather than on politics; his role as the voice of reason; continuing the legacy of Scott Wyant; the need for City Council recognition of the value of having an architect on the Commission; she asserted that inspirational buildings would not continue in the City unless there is a voice that stands up for design; she discussed going beyond the numbers; getting to the final project; she hoped that nuggets of Mr. Ogosta's knowledge continue with the Commission; she expressed regret at not being able to be present; and appreciation for being able to serve with Mr. Ogosta for most of his term.

Erika Ramirez, Current Planning Manager, read a letter into the record from former Community Development Director Sol

Blumenfeld expressing appreciation for the extraordinary accomplishments of Ed Ogosta and David Voncannon.

Mark Muenzer, Planning and Development Director, presented Ed Ogosta with a gift from the City in appreciation for his service.

Chair Jones proposed adjourning the meeting in honor of former Commissioners Ogosta and Voncannon.


Commissioner Reilman noted that Juliettes and articulation were the words of the day in honor of Ed Ogosta.
