Angus MacDonald, Monarch Theatre Guild, provided background on the organization; discussed recent productions; and he

Items From Staff

Susan Obrow, Special Events Coordinator, distributed Performing Arts Grant performance calendars to Commissioners and discussed upcoming performances; she announced that the 2017 grant application would be available next week and would include performances for the Centennial; she discussed promotion of the grant opportunity; the process and schedule; she provided an update on renovation of the Veterans Memorial Auditorium; and she discussed the schedule of events for Fiesta La Ballona August 26-28 and encouraged everyone to attend.

Christine Byers, Cultural Affairs Coordinator, introduced Administrative Services Director Serena Wright-Black, noting that she had taken on the task of studying cultural affairs and working to obtain more assistance for the existing staff.

Susan Obrow, Special Events Coordinator, reported that Mari Sullivan had joined Cultural Affairs as a contract employee

working a maximum of 30 hours per week on performing arts projects, and she added that the Los Angeles County Arts Commission intern would be helping this summer and she was very appreciative of the assistance.

Christine Byers, Cultural Affairs Coordinator, discussed the transition of Gayle Smashey and completion of various projects; recruitment of a part-time contract employee; duties of the new position; a recent donation from the Syd Kronenthal estate for the technical enhancement of Veterans Memorial Auditorium; installation of the permanent public art for the Access Culver City project; the fog component of the sculpture; total water usage; impacts of the proposed remodel of the Sony Pictures Plaza building to the existing permanent art pieces located at the site; distribution of the current year budget; and effects of the transition to the new legislative management system and the new website on the archives.

Items from Commissioners

Chair Dickter expressed appreciation for the Syd Kronenthal donation and for the addition of Ms. Sullivan.

Commissioner Williams received an update on the opening of The Wende Museum; asked about status of The Jazz Bakery; and he welcomed new Commissioners Wisnosky Stehlin and Pali.

Vice Chair Cherry received an update on the cost and status of the lighting upgrades, stage rigging and emergency upgrades for Veterans Memorial Auditorium, as well as next steps in the process; clarification on the applicability of the Getty Multi Cultural Internship Program; and the rate of pay for the part-time position.

Chair Dickter reminded new Commissioners to nominate their candidate for the Cultural Affairs Foundation Board; reported attending the Centennial Arts and Cultural subcommittee meeting, as well as the Los Angeles County Cultural Equity and Inclusion Initiative Town Hall; discussed the Performing Arts subcommittee; wrapping the Centennial into the overall programming schedule; and he reported receipt of an email

requesting him to join an Audience and Participants Working Group.

Commissioner Wisnosky Stehlin agreed that the roundtable was excellent; reported that she is part of the Executive Director Arts Affinity Program through the Los Angeles County Arts Commission; discussed cities looking at separating the Foundation from the city and those looking to connect; she was interested in how the Commission could be more involved in the Centennial in an official capacity; and she reported attending the performance of the Culver City Symphony Orchestra at the Kirk Douglas Theatre.

Chair Dickter provided background on the formation of the Centennial Committee; discussed Brown Act issues; and additional ways to assist the Committee appropriately.

Discussion ensued between staff and Commissioners regarding forming a new subcommittee to help with the Centennial; the Performing Arts Grant Subcommittee; the desire for collaboration; permanent art; clarification that the money raised has been for marketing and promotion but not for programming; public art; previous consensus to agendize a discussion regarding the Foundation; City Council review; Commissioner consideration; the process; the intentions of the Mayor; inclusion on the August agenda; and the focus on the Commission's position on the memorandum.

Chair Dickter proposed a motion to agendize a discussion and recommendation to the City Council regarding transferring the Cultural Affairs Foundation to a private 501(c)(3)with a Memorandum of Understanding with the Cultural Affairs Commission.

Additional discussion ensued between staff and Commissioners regarding agendizing a conversation and returning with a recommendation; concern that time is of the essence; including others with an opinion on the matter in the conversation; Foundation Board members; adding the item to the agenda for the August meeting; having an open-ended discussion; clarification that staff would not provide information on the item; timing of City Council consideration of the item after Commission consideration; communication; and clarification that a motion is not necessary to agendize an item.
