In-Depth Discussion and Planning of Parks, Recreation and Community Services (PRCS) Commission Community Conversations - Topic #7, with the Working Title, "Race, Religion, and Culture: Living in Harmony within our Community"

Commissioner Garland reported on progress made; announced the topic as "Growing Up in Culver City: A Continuing Conversation on Culture and Race"; noted that the main question for panelists is: What is it like growing up in Culver City and what are your experiences, good and bad?; he reported on a meeting with Assistant Principal McMillan at Culver City High School who expressed support for the scope of the conversation as explained; discussed an email chain with other local educators, who voiced their support; reported that the exact format had yet to be dialed in; and he asserted the goal was to find a way to bring back happiness and harmony to the community as it relates to different races and cultures.

Discussion ensued between staff and Commissioners regarding clarification on what the wrap up or take away from the meeting would be; usage of a facilitator; participation by school counselors or school psychologists; the target audience; goals of the Conversation; excitement for the Conversation; further refinements; whether to have a one-time or an ongoing Conversation; whether middle school and high school

students would participate in the same Conversation; ensuring that students from Culver Park participate; involving students from West L.A. College; grouping participants by age; concern with having too many people speaking; breaking the topic into two Conversations; and support for the topic working title and progress made to date on the item.

Chair Heineman invited public input.

The following member of the audience addressed the Commission:

Michele Weiner discussed her monthly participation in a race dialog held just outside the City limits; expressed her excitement and curiosity for the Community Conversation; encouraged the Commission to ensure Culver City High students who are not residents are included; offered her connections and resources to the Commission; and she asked who would be generating the questions for the conversation.

Further discussion ensued between staff and the Commissioners including the origin of the questions for the Community Conversation; the topic title; revising the title to include going to school in Culver City; and clarification that the agenda title indicated that the item is in the planning stage.

Michelle Weiner reported publicizing the agenda item on her Facebook page and she reported that people wanted to attend the planning meeting.
