PC - Administrative Site Plan Review, P2016-0228-ASPR, and Tentative Parcel Map No. 73877, P2016- 0228-TPM, for the Construction of a Three (3) Unit Condominium Subdivision at 12464 Washington Place in the Residential Medium Density Multiple Family (RMD) Zone

Gabriela Silva, Associate Planner provided a summary of the material of record.

Chair Voncannon invited public comment.

The following members of the audience addressed the Commission:

Neil Palmer, applicant, discussed the project and felt it was a nice fit for the neighborhood.

Discussion ensued between the applicant and Commissioners regarding architectural materials used; colors; the use of concrete block; additional space for bicycles; trash areas; clarification that the units are intended for sale; existing street trees; improving landscaping in the area but not removing trees; and the top down design of the units.

Andrew Donnelly expressed appreciation for the design; he asserted that the project belonged in Playa Vista rather than the proposed location; he commented that the existing house was the only one in the neighborhood; he noted that every inch of space on the lot was being used and felt that the structure was way too big for the neighborhood; and he asked for discretion and adjustments so that the structure did not loom over the neighbors.

Josh Hamilton echoed comments made by the previous speaker; expressed concern with the size of the project; discussed the unpaved alley and the mezzanine; he observed that the structure did not look like anything else on the block; and he expressed concern with living in the shadow of a large building.

Discussion ensued between staff and Commissioners regarding plans to pave the alley; the Washington Place frontage; consideration of the properties on Washington Place and how they are zoned; dense development and increased lot coverage on the Los Angeles side of the street; how the project fits in with the neighborhood; the Urban Forestry Master Plan; removal and replacement of trees; replacing one housing unit with three; a suggestion to adjust Condition 29 to ensure that the address is visible not only from Washington Place but also from the backside; appreciation that the project is 3 units rather than 4; on-grade parking with minimal excavation; acknowledgement that it is rare that a developer comes forward that does not maximize every bit of space; balancing the interests of the community with the interests of the developer; sensitivity to buildings in the neighborhood and ensuring a more sensitive response; zoning; acknowledgement that the project meets qualifications; the benefit of additional housing units to the neighborhood; appreciation that the plan does not take advantage of the third story; an assertion that there is no reason to preserve single family homes on a major boulevard; increasing densification on the boulevard to preserve single family homes in other areas; concern with the loss of characteristic single family homes; historic preservation; ensuring that things being built are something to be proud of; stringent guidelines in Culver City; the importance of renderings and contextual drawings to see projects in context; redevelopment of older housing stock; economics; and agreement to add the signage requirement to Condition 29.

1. ADOPT A CLASS 3 AND CLASS 15 CATEGORICAL EXEMPTION FOR THIS PROJECT PURSUANT TO CALIFORNIA ENVIRONMENTAL QUALITY ACT SECTION 15303 NEW CONSTRUCTION OR CONVERSION OF SMALL STRUCTURES AND SECTION 15315 MINOR LAND DIVISIONS.; AND
2. APPROVE ADMINISTRATIVE SITE PLAN REVIEW, P2016-0228-ASPR AND TENTATIVE PARCEL MAP NO. 73877, P2016-0228-TPM, SUBJECT TO THE CONDITIONS OF APPROVAL AS STATED IN RESOLUTION NO. 2017-P008 (ATTACHMENT NO. 1) WITH ADDITIONAL SIGNAGE REQUIREMENTS ADDED TO CONDITION 29.
