CAC - (1) Presentation of Updated City Council Policy Regarding Commissions, Boards and Committees; and (2) Comments to the City Council Subcommittee and Staff as Deemed Appropriate

Council Member Jim Clarke discussed the composition of the City Council subcommittee and provided a summary of the material of record.

Heather Baker, Assistant City Attorney, discussed the consolidation of policies for Commissions, Boards and Committees.

Discussion ensued between Council Member Clarke, staff and Commissioners regarding meaningful changes to the policy; the process for bringing items forward to the City Council; clarifying the process for adding an item to an agenda; the need for City Council approval for items requiring significant staff time and resources; day-to-day operations of Commissions; things that apply to Commissions that do not apply to Committees and Boards; compensation; absences from meetings and grounds for removal; frequency of meetings; prolonged absences; City Council consideration of the policy; and appreciation to the City for the inclusivity of the Commissions.

Louise Coffey-Webb, Public Art Collections Manager, reported that the large Culver City seal outside the entrance to the Council Chambers had been cleaned just in time for Incorporation Day.

Christine Byers, Cultural Affairs Coordinator, discussed the last Heidi Duckler Dance performance for 1988; video documentation; and she suggested that Marla Koosed come to make a summary presentation at a later date.

Commissioner Williams discussed Culver City galleries participating in the Getty supported Pacific Standard Time: LA/LA (Latin America/Los Angeles) project and she encouraged everyone to attend.

Vice Chair Wisnosky Stehlin reported attending the Party in the Park on Saturday; discussed theatre productions as part of the LA Stage Alliance; the Ovation Awards; and she reported that an article from *A Place for Mom* ranked Culver City as No. 4 on a list of places to retire to as it is a cultural paradise.

Commissioner Fleischer provided background on Malena Dobal Parra noting who she has appointed to serve on the Cultural Affairs Foundation Board. She also reported a Centennial celebration at the Frost Auditorium on September 20.

Chair Dickter reported watching the final 1988 performance via a remote livestream; noted that City Council consideration of the Centennial Garden agenda item had been postponed; commented that the Commission would be busier in the next few months; and he noted that the celebration event for the publication of the Creative Economy report would be on September 27.

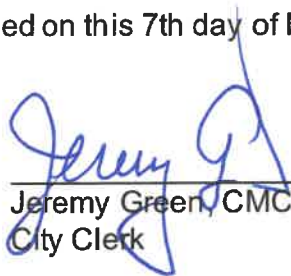
