### **Public Comment - Items Not On the Agenda**

Chair Dickter invited public comment.

The following members of the audience addressed the Commission:

Dr. Janet Hoult indicated that she would provide a report to the City Council on the Artist Laureate Program in February; congratulated staff and Commissioners who worked on the Program; indicated that her poetry books were connected with what is going on in Culver City and she suggested that future Artists Laureate do the same; she reported that proceeds from her poetry book featuring dogs would go to the Culver City

Dog Park; and she read a poem titled, "Where Did Thanksgiving Go?"

Chair Dickter thanked Dr. Hoult for her efforts as Artist Laureate for Poetry.

Tommy Lee, American Cancer Society Senior Development Manager, provided background on himself and distributed information to Commissioners; reported on ACS events in Culver City; announced an upcoming event featuring food and wine on July 22; suggested that the Cultural Affairs Commission might want to sponsor local entertainment at one of their events; discussed art installations; site-specific artworks at the Sony Pictures Studio lot; and creating a kickoff event to engage local businesses.

Discussion ensued between staff and Commissioners regarding engaging with organizations; forming a beneficial partnership; agreement by staff to meet with Mr. Lee; the City's Special Events Grant Program; timing; and City policies.

Chair Dickter introduced the item.

Susan Obrow, Special Events Coordinator, provided a summary of the material of record and read the list of proposed grant recipients.

Chair Dickter invited public comment.

The following members of the audience addressed the Commission:

Myles Lee, Los Angeles Doctors Symphony Orchestra, thanked the subcommittee for their recommendation and Susan Obrow and the staff at Veterans Memorial Auditorium; discussed positive experiences at Veterans Auditorium; increased visibility with networking at Chamber of Commerce morning meetings; and renewed efforts with the Culver City School District.

Matthew Hetz, Culver City Symphony Orchestra, thanked Susan Obrow, the City and Sony Pictures Entertainment; discussed the planned concert at the Kirk Douglas Theatre; parking charges; he requested a waiver or a reduced parking rate; and he discussed outreach and promotion.

Chair Dickter thanked Mr. Hetz for his comments on parking.

Daniel Corral, Society for the Activation of Social Space through Art and Sound (SASSAS), appreciated the opportunity to present a performance in the City at the Baldwin Hills Overlook, and he discussed the past performance in October and the planned performance in 2018.

Louise Reichlin, Los Angeles Choreographers and Dancers, provided background on the organization; thanked the subcommittee for their recommendation; and she discussed the planned project.

Donna Sternberg, Donna Sternberg Dancers, discussed the importance of grants for arts organizations; planned performance; and she thanked the City for the support.

Jennifer Mulder, Vox Femina, provided background on the organization; reported being invited to perform at the Women's March in Pershing Square; discussed their expansion of youth education and outreach; expressed appreciation for previous grants; thanked Susan Obrow; and she invited everyone to attend their planned grant performance.

Nicola Henry and Lauren Bruniges, Culver City Public Theatre, noted that 2018 is the 20<sup>th</sup> year that Culver City Public Theatre has provided free theatre in Carlson Park for children and adults, and she thanked the City for all of their support.

Raymond Jacobs, Kontrapunktas, provided background on the organization, and thanked staff for their assistance and the City for their support.

Jeff Gauthier, Jazz Bakery, reported celebrating their 25<sup>th</sup> anniversary in the City; expressed appreciation for the grant, to the City for the support and to staff for the ease of the process; and he discussed the proposed grant performance.

Chair Dickter thanked former Commissioner John B. Williams for his role in the process.

Discussion ensued between staff and Commissioners regarding appreciation to Subcommittee Members and those involved in the process; the balance of art forms in the City; diversity in the City; engagement; cultural equity; programming; acknowledgement that the grants often act as a stepping stone for younger organizations;; outreach to the schools; and first time recipients vs. repeat recipients.


