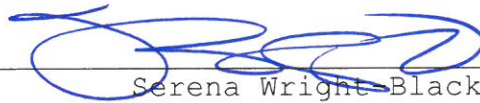
Discussion ensued between staff and Council Members regarding Commission discretion and the pre-hearing conference, and scheduling.
