Discussion ensued between staff and Commissioners regarding certification requirements; a suggestion to indicate it is highly desirable that the Senior Public Works Inspector be certified as well as for the entry level position; clarification that the entry level position does not require any supervision; agreement to indicate that having the certification is highly desirable; changes to language indicating that college degrees are no longer required but desirable; the relevance of what was studied in college; college experience vs. work experience; concern that the language could dissuade someone from applying; and distinguishing applicants in the pool of candidates.

Serena Wright-Black, Administrative Services Director, provided a summary of the material of record noting that direction was needed from the Commission regarding start time.

Discussion ensued between staff and Commissioners regarding of the hearing; reserving additional availability of the attorney for the City; whether the Brown Act precludes discussing dates; establishing dates through polling methods; concern with any discussion pertaining to a matter over which Commissioners have jurisdiction; concern with the appearance of violating the Brown Act; procedures for Commissioners who cannot be present for two of the meetings; a past experience with an unplanned absence and Commissioner participation allowed after a review of transcripts; due process concerns; live witness testimony similar to a trial; assessing the credibility of the witness; body language; evidence that is not available with a transcript; participation with approval from both parties; waiving due process claims; waiver of challenges based upon the absence of a Commissioner who is reviewing a tape; caution against moving forward with allowing an absent Commissioner to participate; whether to move forward with four Commissioners or look for dates that will work with all five; the need for a quorum; constraints of the schedule of the attorneys; different options; waiting until October; the desire to have all five Commissioners attending; clarification that agreed upon dates include July 23, 25, August 6, 13, 20, 22 and 27; the preference to start the meetings at 6:30 p.m. and continue until sometime between 10 p.m. and 11 p.m.; and meeting location.

Discussion Regarding Disciplinary Appeal Processes and Provide Direction to Staff as Deemed Appropriate

Serena Wright-Black, Administrative Services Director, provided a summary of the material of record.

Discussion ensued between staff and Commissioners regarding the staff recommendation to the Commission; making a recommendation to the City Council; support for turning off the cameras and closing Council Chambers to the public during a closed hearing; clarification on what a Skelly Hearing is; including clarification on what a closed hearing is in the rules; witnesses in a closed hearing; the feeling that

specifics should not be included in the letter; ensuring that bias is not formed; putting up signs to keep people from wandering into a closed hearing to get their parking validated; the hearing request; codifying the process; the process for making revisions to the Civil Service Rules; the written statement of issues being appealed; the pre-hearing conference; the need for the appellant to clarify what is being appealed but not the answer to the charges; the typical appeal of all charges; the reference to the Notice of Intent; the evidentiary package; the pre-hearing conference; the joint exhibit list; the joint statement of facts agreed upon by both attorneys; accessibility of information included in the appeal; the request from Chair Kuechle to see information referred to in the letter of appeal; disciplinary documents; open issues; the need for Commissioners to know all of the information to make a decision; agreed upon facts; issues that the two sides disagree on; concerns expressed by previous Commissions; concern with skewed information; summary of charges; the request for changes to be made to the Civil Service Rules to indicate that the meeting will be closed when an employee asks for a closed hearing and the employee does not have to supply a written answer to the charges when an appeal is requested; clarification that the Chair and Vice Chair are required to attend the prehearing conference, but not the full Commission; allowances in the Brown Act for closed hearings; protecting the privacy of the employee; and ensuring that the item is clearly agendized.
