Action Items

Item A-1

Update - 2018 Homeless Count Subcommittee (Members Gibson, Puza and Wallace)

Member Puza reported meeting with GIS staff; discussed clarification on City borders; differentiating between Los Angeles county and Culver City; having an app with the map; creating an attribute table; providing a form to fill out; training; media contacts; creation of a press release; solicitation of volunteers; start time; setup and delivery of products; the schedule; a reminder that Committee Members are responsible for being available for set up and clean up; clarification regarding processes; working to eliminate confusion; formation of groups for deployment; t-shirts; food donations; and prizes.

Discussion ensued between meeting participants, staff and Committee Members regarding providing both types of resource cards; clarification that the homeless are not to be engaged during the Count though if approached, volunteers may provide any requested information; providing Members with a supply of the resource cards; solicitation of volunteers; the use of bottled water; City policy; sustainability; hygiene; a suggestion to include a reminder for volunteers to bring their own water; attendance by Council Members; participation; having a plan if there are too many volunteers; accommodating walk-ins; jurisdictions that do not get enough people; deployment outside of Culver City; redeployment of teams if there are not enough volunteers; establishment of a cut-off; drop off from website signups; ensuring that people are prepared to stay late; groups that rush through the process; keeping teams to four people; those people who want to stay with their friends; walk in traffic; website information; directing people to other locations; coordination with faith based organizations; providing clear direction; clarification that those under 18 are not allowed to deploy; sensitivity of the Los Angeles Homeless Services Authority (LAHSA) to the media; sign-in; the ability of the press to take photographs and film participants; whether a signed release is necessary; posting a notice indicating that by participating, you consent to be photographed; credentials; wristbands; ensuring that people sign in; the downtown deployment team; parking structures; walking teams; cycling teams; vests; changes from the previous year; working to improve accuracy; City Council approval of the Memorandum of Understanding (MOU) and donations and volunteers for the next three years to expedite the process; subcommittee meetings; use of the GIS app with other cities; linking information; procedures at the end of the evening; LAHSA interface with the app; individual maps for each team; creating a database; facilitating follow up assistance; identifying areas of concentration; limiting access to the app; and recording length of time to do each section.

Item A-2

Update - Los Angeles County Homeless Initiative Subcommittee (Chair Diamond, Members Fisch and Silbiger)

Vice Chair Silbiger discussed the planning grant from the county to update the homeless plan; outreach for proposals; the role of the subcommittee in the process; the timeline for consultant selection and completion of work for City Council approval; examination of the current plan; community meetings; consultation with community organizations that work with the homeless; meeting facilitation; interaction with partner organizations; identification of possible stakeholders; and identification of available monies.

Discussion ensued between meeting participants, staff and Committee Members regarding the short time frame for completion; consultant suggestions; the importance of Member attendance of community meetings; and distribution of landlord materials.

Item A-3

Homeless Case Studies/Client Outreach Presentation of Case Studies Examining Best Practices and Homeless Community Updates

Member Capone-Newton discussed his work with the Veterans Administration (VA); his experiences with veteran homelessness; services available to veterans; eliqibility for healthcare benefits; the national hotline to connect veterans with services; connecting with local staff; the Veteran Crisis Line; the Housing First priority; helping people transition; available resources; the Welcome Center; short term housing on the VA campus; the master plan to create 1200 additional units of permanent Section 8 housing on the west Los Angeles VA campus; the case of an 84-year old man in Santa Monica who lost his housing and is working with the Veterans Administration Supportive Housing (VASH) program to find a place to live; younger veterans; tobacco cessation treatment; social and economic resources; substance abuse issues; mental health issues; younger people on the streets; the percentage of people on the streets with mental health issues; financial benefits from

the military; understanding how to engage and serve everyone; and addressing those who cannot find a place using the traditional model.

Discussion ensued between meeting attendees, staff and Committee Members regarding making changes to discharge status; case management; housing services; hours of operation for the crisis hotline; housing options for veterans; services for those with chemical dependency; the California Veterans Home; the primary driver for homelessness; the relationship of homelessness to income and housing; the economic and social nature of the homelessness problem; population growth in Los Angeles in relation to housing growth; dislocation; difficulties finding housing; providing affordable housing throughout the community; avoiding areas of concentrated poverty; migration; clarification that Culver City is too small to participate in VASH but administers the vouchers; the portable nature of the vouchers; the cap on the vouchers; housing affordability; people who relocate to the Antelope Valley for affordability but then cannot access jobs or healthcare; COLA vouchers; the limited time frame for the validity of the vouchers; demographic shifts; the fact that greater numbers of people are leaving Los Angeles than coming in; veterans who want to stay put because their support system is here; lapse of vouchers; gentrification of other areas; socially acceptable modes of living; the number of people actively using VASH; creative ways to promote affordable housing in Culver City; industry partners; the concentration of wealth in Culver City; creating a more equal community; the growth of Housing and Urban Development (HUD); Housing First; roommate sharing; requiring one voucher per bed; development standards; downsizing; changing design standards; and lowering costs.

Larry Kaufman discussed the grant per diem program to house people quickly while getting into the VASH program; religious issues; the resource card for veterans on the internet; California Veterans Homes throughout the state run in conjunction with the VA; participation requirements; and available services.

Additional discussion ensued between meeting attendees, staff and Committee Members regarding location of the California State Veterans Home; retirees; the facility in North Hills; the waiting list; extending the decision to provide veterans housing to the rest of the population;

alternative design standards; creating different housing types; and the General Plan.
