Discussion ensued between meeting attendees, staff and Committee members regarding St. Augustine Church; food distribution; available services; a suggestion to rotate locations and to invite SPLA to make a presentation at a Committee meeting with an invitation extended to faith based organizations; a suggestion to recommend a study to the City Council; meals provided by Grace Lutheran; bathroom facilities; outreach; the transitory nature of the population; and consensus to move forward with exploration of providing safe parking for those living in their cars

Item A-3

Update - Los Angeles County Homeless Initiative

Tevis Barnes, Housing Administrator, discussed the recent meeting of the Homeless Initiative Subcommittee; implementation of the planning grant from the county; City legal review of the contract; the need for City Council approval of the contract; letters of solicitation for consultants to implement the grant; community meetings; and the role of the Committee in reviewing the Requests for Proposal (RFPs) and interviewing candidates.

Discussion ensued between meeting attendees, staff and Committee Members regarding clarification that the grant is a one-time grant to update the homeless plan; land use issues; encouraging the development of affordable housing and shelters; Measure H; prioritizing homeless initiative strategies; going after available funds; county matching funds; researching what to focus on; and appreciation to staff for their work on the contract.

Member Wallace joined the meeting.

#### Debrief - 2018 Homeless Count Subcommittee

Discussion ensued between meeting attendees, staff and Committee Members regarding the number of volunteers; approval to solicit volunteers and donations for the next three years; certificates of appreciation distributed to volunteers at the City Council meeting; a request for a letter from the Chair to the vendors who donated; signage indicating those businesses who donated food; the inability to release figures until approved by the Los Angeles Housing Services Authority (LAHSA); the GIS maps used by Culver City; coordination between Culver City and Los Angeles GIS personnel; an observation that individual numbers are down, car numbers are up and others are the same; work by St. Josephs to get people off the street; the theory that construction is moving people out of certain areas; the feeling that the Count was very organized; the training video; appreciation for the introductory speech; subcommittee work on the Landlord Fair; and appreciation to staff for their work on the Homeless Count.

Tevis Barnes, Housing Administrator, announced that Eliana Garzaro would be moving out of state and Ashleigh Blackman would be taking her place.

Item A-1

Homeless Case Studies/Client Outreach Presentation on Senate Bill 35 - Planning and Zoning, Client Outreach and Status Updates

Chair Fisch reported that a determination had come out from the state Housing Community Development Department on SB 35; he discussed failure to meet housing targets; the Regional Housing Needs Allocation (RHNA); projected growth; accountability; discretion; ministerial approvals; guidelines; neighborhoods in Culver City that allow mixed use development; he indicated that if projects meet state guidelines in cities that have failed to meet their target numbers, discretion is taken away that city; he discussed parking requirements; and legislation enacted because cities have failed to meet their RHNA numbers.

Discussion ensued between meeting participants, staff and Committee Members regarding resistance to SB 827; compliance; showing capacity to build; actually building projects; conditions placed on projects; Globe Avenue; the half a mile radius from the train station; providing a good deal to builders; increased construction; providing homes for those who need them; SB 27; local control; height limits; density limits; inclusionary zoning; informing potential developers about the law; an observation that cities that do not meet RHNA numbers face a lack of control; recommendations to the City Council to try to address the issue; the sunset date; state intervention when cities do not deal with housing needs; California redevelopment law regarding affordable housing; potential lawsuits; prevailing wage provisions; parameters that do not override local authority; available density bonuses; and new statutes approved in January.

## Homelessness Criminalization: Discussion Examining Homelessness and Criminalization

Chair Fisch discussed an article in the LA Times on the criminalization of the homeless; the request for comment from the LA Weekly; the decriminalization strategy; the uptick in enforcement of minor violations against people who are unhoused; and monitoring the strategy to decriminalize homelessness.

Discussion ensued between meeting attendees, staff and Committee Members regarding categorization of violations; transient and public drunkenness calls; using the outdoors as a bathroom; availability of public bathrooms; drunk bar patrons who are not homeless; the importance of having a police department representative attend Committee meetings; whether Los Angeles criminalizes someone sleeping in a car; harassment of the homeless; positive interaction with the Culver City Police; an update on Robin, a former homeless individual who has found housing in Koreatown and his positive feedback on the Culver City Police Department.

#### Item A-4

Fiscal Year - 2018-2019 Budget: Discuss and Receive Recommendations on the Fiscal Year 2018-2019 City Budget

Tevis Barnes, Housing Administrator, provided background on the item; discussed upcoming hearings; new housing legislation; studying thresholds for the inclusionary housing ordinance; signing bonuses for owners who take tenants with rental assistance; rent catch up grants; utility catch up grants; and first and last assistance.

Discussion ensued between meeting attendees, staff and Committee Members regarding the HIP program in Los Angeles; portability of vouchers; establishing residency requirements; logistics; land use issues; increased density; reductions to parking requirements and permit fees; grants to assist with motel conversions; seed money; waiving business license fees for owners renting to homeless or affordable families; research on housing statutes; implementation of the LA County Homeless Initiatives; the Rapid Rehousing program; finding affordable units in Culver City; what happens after 12-18 months when the subsidy runs out; moving people out of the area; connecting families with services out of the area; in lieu fees; figuring out the right formula to encourage development of affordable units; levels of affordability; concessions; allocating by unit vs. by square footage; linkage fees; effectiveness of the Committee; dealing with the broader issues to address the problem of homelessness; a suggestion to ask for a Homelessness Coordinator staff position; fees for commercial development; and opposition from the Chamber of Commerce.

THE COMMITTEE ON HOMELESSNESS PASSED A MOTION TO RECOMMEND CITY COUNCIL APPROVAL OF COMMITTEE ON HOMELESS BUDGET RECOMMENDATIONS.
