Member Hoult discussed the work of the Culver City Strummers at the Mattel Children's Hospital; their connection with disabled groups; and she reported that the Westside Independent Living Center had changed their name to the Disability Community Resource Center noting that should be kept in mind for next year.

Items from Disability Advisory Committee Members/Staff

John Adams, Disability Services Specialist, indicated that he would be in touch with Members regarding their roles in the Carnival; he provided an update on preparations for the Carnival; he encouraged Members to reach out to him with updates on their work; and he noted that reservations were already coming in.

Member Hoult reported distributing a copy of all commendations through 2014 to Committee Members; discussed updating the list; and the value of recognizing people helpful to the disabled.

Discussion ensued between staff and Members regarding outreach to area schools; outreach to Culver City

newspapers; distribution of electronic and hard copy fliers; outreach to disability organizations; identification of special education schools; the focus of the Carnival on disabled individuals in the Culver City area; sponsorship by the Exchange Club; limited funds; guests and volunteers; staff agreement to coordinate City email with Member Palley; attendees who have come to the Carnival for 15 years; successful outreach; Hawaiian attire at the Carnival; and Senior Center Association funding.

Member Palley indicated that she was eager to serve on the Committee.

Member Hasegawa discussed the Senior Center budget situation noting that an additional source of funding might be necessary for 2019.

Member Sookne discussed participation since the beginning of the Carnival by the Girl Scouts and development of special booths for those with limited abilities.

Member Hoult welcomed Member Palley to the Committee and suggested agendizing recognition for the work of former Member Effros-Schwartz.

Member Osborne received clarification that staff would inventory art supplies.

Chair Shery received clarification that staff would send Committee Members notification as to when the awards would be presented by the City Council and he reported that the request had already been made to recognize Barbara Effros-Schwartz for her service.

John Adams, Disability Services Specialist, indicated that he would coordinate recognition for Barbara Effros-Schwartz with the City Clerk's office, and he announced an emergency preparedness event at the Disability Community Resource Center on September 21.

Chair Shery reported that the barbeque grill had gone missing from the Senior Center noting that if it is not located someone has offered to a loan their barbeque for use at the Carnival.

Discussion ensued between staff and Committee Members regarding coordination; scheduling to allow time to properly clean the grill; and storage.

Member Tenensap received clarification regarding Wheelchair Basketball on October 26.

John Adams, Disability Specialist agreed to provide additional information to Committee Members.
