Public Hearings

Item PH-1

PC: Administrative Site Plan Review & Administrative Use Permit, P2019-0104-ASPR/P2019-0104-AUP to Allow a 9,338 sq. ft. Addition to a Creative Office Building Spanning Two Adjoining Commercial Lots Currently Developed with a 7,500 sq. ft. Building that will Result in a Total of 16,839 sq. ft. Three-Story Building with Mezzanine to Include On-Site Improvements Such as a Parking Lot Restriping, New Parking Stackers, and New Hardscape/Landscape, at 3516 Schaefer Street

Commissioner Ogosta indicated that he had previously done business with the applicant so he recused himself and exited Council Chambers.

Lisa Edwards, Planning Division Contract Planner, provided a summary of the material of record.

Michael Allen, Planning Manager, thanked Commissioner Voncannon for bringing an error to his attention; he provided corrections to the Conditions of Approval noting duplicate conditions; and he indicated that Condition 102 would be deleted as it is a duplicate of Condition 97 and Condition 104 would be deleted as it is a duplicate of Condition 98.

Discussion ensued between staff and Commissioners regarding remnant parcels; prior use; and stacker parking.

Chair Reilman invited public participation.

The following members of the audience addressed the Planning Commission:

Ileana Acevedo, RAC Design Build, provided an overview of the project; discussed operation of the parking stackers; transportation amenities; alignment with City goals; materials used; intent to develop the spur remnant; and exterior decks.

Discussion ensued between project representatives, staff and Commissioners regarding afterhours access; utilization of the parking stackers only during business hours; energy efficiencies; compliance with Title 24; the property to the north; and developer purview.

Adam Lev, Redcar Properties, reported on the recent purchase of the property to the north and discussed energy efficiency.

Discussion ensued between project representatives, staff and Commissioners regarding glass and orientation; glazing; Title 24; and insulated glass.

Deborah Krelle questioned whether there were provisions in place to prevent people from parking in the facility at night; length of construction; and impacts to nearby residents.

Ileana Acevedo, RAC Design Build, noted that the parking area was private property; she indicated that a gate had not been designed for the project but they would be open to that possibility; she discussed the anticipated construction

schedule; building permit approval; and the projected timeline.

Adam Lev, Redcar Properties, indicated that they were still awaiting approvals but anticipated finishing in early 2021; he discussed parking access; responsibility of the tenant; private property; access; and impacts.

Discussion ensued between project representatives, staff and Commissioners regarding the required Construction Management Plan; hauling routes; and staging areas.

Discussion ensued between staff and Commissioners regarding concern with the starkness of the wall on the north side; the Art in Public Places ordinance; murals; valuation of the project; visual relief; redundancy in Conditions 78 and 79 and agreement to delete Condition 78; concern with the thermal barriers; energy efficiency; concern with not having a copy of the presentation earlier; appreciation for public input; appreciation for the transition of the massing; precedent for art in the Hayden Tract; temporary vs. long term addressing of the blank wall; administrative site plan and use plan; the categorical exemption to the California Environmental Quality Act (CEQA); and agreement to delete Conditions 78, 102 and 104.

MOVED BY COMMISSIONER VONCANNON AND SECONDED BY VICE CHAIR LACHOFF THAT THE PLANNING COMMISSION:

1. ADOPT A CLASS 32 CATEGORICAL EXEMPTION FOR THIS PROJECT PURSUANT TO CALIFORNIA ENVIRONMENTAL QUALITY ACT SECTION 15332 IN-FILL DEVELOPMENT PROJECT.

2. APPROVE ADMINISTRATIVE SITE PLAN REVIEW & ADMINISTRATIVE USE PERMIT, P2019-0104-ASPR/P2019-0104-AUP, SUBJECT TO THE CONDITIONS OF APPROVAL AS STATED IN RESOLUTION NO. 2019-P008

(ATTACHMENT NO. 1) AND THE DELETION OF CONDITIONS 78, 102 AND 104.

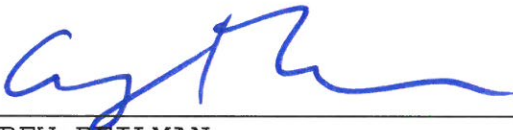

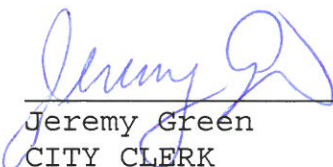
