Action Items

Item A-1

CAC - Consideration of a New Permanent Art Concept by Alex Prager Toward Fulfillment of the City's Art in Public Places Program Requirement for a Project at 8888 Washington Boulevard

Christine Byers, Cultural Affairs Coordinator, discussed fulfillment of the Art in Public Places Program requirement by the Runyon Group, the developer for a project located at 8888 Washington Boulevard; Subcommittee support for the general concept; concerns raised about materials as initially proposed, method of installation and lighting; agreement that Commissioner Pali work with staff and the developer's team to address concerns; and resolution of concerns at the beginning of October.

Jack Nathan provided background on the Runyon Group, discussed projects developed in Culver City; the focus on design and creating an interesting ground floor retail experience; he provided additional details on the project including location; presented project renderings; and he wanted the art to represent the company, the building, and the Culver City community.

Bianca Collins, the Art Consultant for the project, discussed the artist selection process and the artist chosen, Alex Prager, noting that this would be her first permanent public art installation and was meant to be experiential.

Alex Prager, the Artist, provided background on herself and discussed her interest in the space between reality and fiction; her concept for the artwork; creation of life-sized pictures for the installation; the importance of details; and scale of the figures vs. the background.

Jack Nathan, Runyon Group, discussed honoring the artist's intention and maintaining the integrity of the project; installation of the photograph at the highest resolution possible; appreciation to the Public Art Subcommittee for their feedback to achieve the best result; installation; creating an immersive experience; lifespan of the piece; materials used; maintenance; the anti-graffiti coating; UV protection; the lighting plan; the sun/shadow study; the schedule; project

benchmarks; fees and permits; costs; and the Conservation Maintenance Plan.

Discussion ensued between project representatives, staff and Commissioners regarding materials used; appreciation for the presentation; evolution of the project; confirmation that requirements for the project were met; visibility; lighting; the rendering vs. the actual piece; clarification that the photos were staged; use of images created in 2015 that were not made especially for this project; references to Los Angeles vs. focusing on Culver City; how the piece fits into the landscape of Culver City or is unique to the City; clarification that the piece is more about people vs. being specifically about Culver City; the film industry; fluidity of people between neighborhoods; infusing the past with the present at the same time; representation of a cross section of Los Angeles; specific details in the photo that create connections; creating timelessness; collective memories of different periods; characters that are universally American; use of brand names on the artwork; creating universality; support for the subtlety of the project; representation of post-war America; subject matter and integration; and use of the brick wall.

MOVED BY COMMISSIONER PALI, SECONDED BY VICE CHAIR DICKTER AND UNANIMOUSLY CARRIED, THAT THE CULTURAL AFFAIRS COMMISSION:

- 2. THAT THE APPLICANT BE REQUIRED TO MAKE ANY NECESSARY ADJUSTMENTS TO THE LIGHTING AS MAY BE DEEMED NECESSARY BY STAFF AND/OR THE CULTURAL AFFAIRS COMMISSION PUBLIC ART SUBCOMMITTEE PRIOR TO RECEIVING CERTIFICATE OF OCCUPANCY.

Lee Lawlor, Performing Arts Program Associate, provided a summary of the material of record.

Christine Byers, Cultural Affairs Coordinator, announced that on October 22, 2020 Otis College of Art and Design would he holding a webinar on Race and The Creative Economy; she discussed the three-part live drawing session with Artist Laureate Alexey Steele drawing Dr. Janet Hoult on October 6, 8 and 10; attendance numbers; additional events planned in the future highlighting the role of seniors in the community; the upcoming City Council Economic Recovery Task Force agenda item; direction regarding establishing a Virtual Performance Center on the City website; and statistics pertaining to artist/architect representation in the City's extant permanent public art collection.
