The following member of the public addressed the Commission:

Alexey Steele, Artist Laureate, provided a report on the recent Art Walk & Roll Festival; discussed the work of the City to preserve art in Culver City; participation of the Artist Laureate Program in a live city event; the continuing General Plan Update process; policies being shaped and developed for the next 25 years; precedent; support of the arts by the City Council; collective experience; the importance of the arts as highlighted in the national emergency; he announced a collaboration between the Los Angeles County program LA vs. Hate and his Love My Neighbor project; discussed United Against Hate Week, November 13-19; he invited everyone to a live portrait of Candance Pilgram-Simmons at the Wende Museum on November 13 and the City Council Proclamation presentation on November 14; noted the importance of advocacy by the Artist Laureate; providing visible impacts in the city; collaboration with CCUSD (Culver City Unified School District); the Village Well bookstore; and the importance of ensuring the future of the arts.

Chair Fleischer received clarification that staff would send out a GovDelivery email bulletin for the Wende Museum event and she expressed appreciation to Mr. Steele for his points on policy.

Item A-1

CAC - 1) Consideration of a Concept by Marc Fornes/THEVERYMANY Toward Fulfillment of the City's Art in Public Places Program Requirement for The Culver Studios and The Culver Steps

Beau Basse, LeBasse Projects, discussed The Culver Steps; Hackman Capital Partners; project goals; the artist; the view from the Culver Hotel; engagement opportunities; providing a backdrop for large and small activations; shading; scalability; sightlines; involvement of the hotel in the design process; size of the project; different levels of sculptural engagement; color; and widespread support received for the project.

Mr. Basse, staff, between Discussion ensued Commissioners regarding color choice; fulfillment of stated goals; the landmark piece; drawing people in to engage with the space; providing shade; the intent for the piece to be an active part of the community; potential use of a gradient providing places for people to sit or climb; interactivity; concern that the white color would get dirty; the intentional design to make it difficult to climb; strength of the structure if it is climbed; the process; the timeline; the performance space with the sculpture as a backdrop; vantage points; sightlines; structural supports; a suggestion to project colored lights onto the sculpture if it is white; acoustics; sound; clarification that the sculpture does not contain any sharp edges; concern with prevention; maintenance; security; graffiti lighting; the jacaranda trees used for the inspiration; and concern that if the structure is white it will look like fungi.

MOVED BY COMMISSIONER O'CARROLL, SECONDED BY COMMISSIONER WISNOSKY STEHLIN AND UNANIMOUSLY CARRIED, THAT THE CULTURAL AFFAIRS COMMISSION: APPROVE AN ART CONCEPT BY THEVERYMANY TOWARD FULFILLMENT OF THE APPP REQUIREMENT FOR A PROJECT BY HACKMAN CAPITAL PARTNERS LLC AT THE CULVER STUDIOS AND THE CULVER STEPS.

# Item A-2

CAC - Consideration of a Concept for a Permanent Art Installation by The Haas Brothers Toward Fulfillment of the City's Art in Public Places Program Requirement for a Project at 3512-16 Schaefer St. and 8570 National Blvd.

Beau Basse, LeBasse Projects, provided background on the project; discussed consideration of the two developments as a single project; restaurant/retail; background of the artists; adding humor, excitement, and memorability to the project; scale; a suggestion that both figures have lighting; budget; going out of pocket rather than meeting the bare minimum; and the finish and color of the sculpture.

Discussion ensued between staff and Commissioners regarding the process and timeline; work with the Planning Commission; the contrast between the characters and the modern industrial building; support for the holistic approach; lighting; continuity between the characters; visibility; appreciation for the statement made with the playful public art; height exceptions for architectural features; precedent; materials; rigidity of the hanging lights; height of the orbs; Instagram-able moments in the city; and Commissioners expressed eagerness to meet the artists.

AT 3512-16 SCHAEFER ST. AND 8570 NATIONAL BLVD.
