Mayor Lee noted that Items A-1 through A-4 were presentations from the Clean Power Alliance and would be heard continuously with questions from the public and Subcommittee Members taken at the end.

Agenda Items

Item A-1

Receive a Presentation from the Clean Power Alliance regarding the Net Energy Metering (Rooftop Solar) Program

Matt Langer, Chief Operating Officer from the Clean Power Alliance, provided background on the Clean Power Alliance; indicated willingness to stop and answer questions at any time; discussed renewable energy; rates; transmission; forecasts; the under-collection by SCE (Southern California Edison); Net Energy Metering (NEM); solar; excess energy generated; disclosure of power sources; variations in sourcing; reevaluation of the NEM program; subsidies; legacy treatment; export compensation; non-bypassable charges; fixed charges; ensuring people pay their fair share; incentives for

low-income and disadvantaged customers; the Power Share Program; Community Solar; the CARE program for low-income customers; funding through the PUC (Public Utilities Commission); eligibility; and available discounts.

Discussion ensued between Mr. Langer, staff, and Subcommittee Members regarding SCE's Power Charge Indifference Adjustment (or "PCIA"); energy price volatility; transitioning to 100% renewable faster; community choice aggregations; pre-pay options to buy down obligations; bond financing; rooftop solar; residential rates vs. business rates; government buildings without solar; creation of micro-grids with larger buildings; Community Solar and Power Share; state money to support programs; SB 350; reasons for limiting overproduction; rates paid for rooftop solar over-production; incentives for directing surplus energy to low-income communities; the PUC; backlash from the solar industry on potential fixed charges; policy direction at the state level; incentivizing export compensation; program design questions; changing compensation mechanisms; donations; participation; collaboration with the City on targeted outreach; mailers; identification of eligible people in the City; the Section 8 mailing list; adding information about Power Share to other state program intake applications and counseling; income qualifications; Habitat for Humanity; solar panels; community solar projects; service areas; collaboration with community schools; social services; matching renewable energy developers with member agencies with available sites; coordination with school districts; the CCUSD (Culver City Unified School District) bond measure to install solar panels; the Power Response Program; incentives; Smart Thermostats; device-based programs; and increasing engagement.

Mayor Lee invited public comment.

No cards were received and no speakers came forward.

Additional discussion ensued between Mr. Langer and Subcommittee Members regarding additional opportunities for the City to get the word out about initiatives that would benefit the community; participation in community events; Fiesta La Ballona; size of the City vs. who puts in the most energy; targeting seniors; aging in place; collaboration with the Senior Center; creation of a microgrid; providing assistance to emergency services; amount of energy provided; partnering with energy firms; consideration of alternative

methods; City Council consideration; funding; tax breaks; the amount of electricity needed; location; proximity; low-income housing; Los Angeles city vs. Los Angeles county; continuing programs; corporate partners; program timeline; and next steps.

Item A-5

Receive a Presentation on Drought Status and Recent Changes in Water Use Regulations

Joe Susca, Senior Management Analyst, provided a presentation on drought status and recent changes in water use regulations; discussed non-functional turf; reservoir levels; average national standards; landscape watering restrictions; watering regulations for trees vs. ornamental turf; commercial, industrial, and institutional regulations; the Governor's

Executive Order; reduced frequency and length of landscape watering allowed; and permitted watering hours.

Discussion ensued between staff and Subcommittee Members regarding outreach; lack of ads regarding watering restrictions; the tiered system; penalties for using more than the allotment; enforcement; reporting; staffing; providing a suggestion to the City Council on priorities within Code Enforcement; the vacant Environmental Compliance position; a suggestion to invite someone from Code Enforcement to make a presentation at the next Subcommittee Golden State Water; confidential meeting; customer information; leaf blowers; information available on the website; a suggestion to send out an email blast with information and to post on social media; the climate crisis; future restrictions; and holding a City Council discussion about Code Enforcement.
