### **BACKGROUND / DISCUSSION**

In keeping with the FAC Fiscal Year 2023 Work Plan, the following FAC ad hoc subcommittees will offer reports for discussion, recommendations, and next steps:

- Assets Ad Hoc Subcommittee
  - Members: Bauer, Griffing, Lachoff
  - Purpose: This ad hoc subcommittee was established to analyze real property assets for Culver City, including but not limited to opportunities to maximize revenue at parks.
- Structural Revenue Review Ad Hoc Subcommittee
  - Members: Bauer, Jones, Lachman
  - Purpose: This ad hoc subcommittee was established to identify and review all current revenue sources in the City.
- FAC Anniversary Ad Hoc Subcommittee
  - Members: Griffing, Jacobsen, Di Vincente
  - Purpose: This ad hoc subcommittee was established with the goal of organizing an event commemorating the 10-year anniversary of the FAC's first meeting (May 8, 2013) and to highlight the FAC's accomplishments since its formation.
  - The ad hoc subcommittee was formed on March 8, 2023.
- City Council Engagement Ad Hoc Subcommittee
  - Members: Jacobsen, Jones, Lachman, Lachoff
  - Purpose: This ad hoc subcommittee was established to identify ways to broaden the relationship between the FAC and the City Council.
  - The ad hoc subcommittee was formed on March 8, 2023.
- Affordable Housing Ad Hoc Subcommittee
  - Members: Bauer, Jacobsen, Lachman
  - Purpose: This ad hoc subcommittee was established to formulate a speaker series on the economics of affordable housing and identify potential speakers.
  - The ad hoc subcommittee was formed on April 12, 2023.
- 2024 Government Efficiency Ad Hoc Subcommittee
  - Members: Di Vincente, Griffing, Jacobsen, Lachman
  - Purpose: This ad hoc subcommittee was established to research, implement, and continue a City Innovation Award Program to encourage employees and/or departments to contribute towards increased efficiency, improved quality of life for Culver City residents, reduced costs and/or generated revenue, or to demonstrate distinguished performance based on department goals/outcome measures.
  - The ad hoc subcommittee was formed on July 12, 2023.
