## **BACKGROUND/DISCUSSION**

At the August 6, 2019 meeting, the PRCS Commission reviewed the list of Commission appointments, including those of the Ad Hoc Subcommittee Members. The attached list of Commission appointments has been updated based on the action taken by the Commission at that meeting (Attachment 1).

### Updates from PRCS Commission Representative Appointees

Staff has prepared this report as a standing Agenda Item to give the Commissioners an opportunity hear updates from their colleagues.

### PRCS Commission Ad Hoc Subcommittees

An "ad hoc" subcommittee serves only a limited or single purpose. It is not perpetual, and it is dissolved when its specific task is completed. An Ad Hoc Subcommittee may be formed or dissolved at any Commission meeting, as long as the discussion has been placed on the Agenda in advance. Once an Ad Hoc Subcommittee has been created, updates are typically given by Members during this Standing Agenda Item. By consensus of the Commission, a separate Agenda Item is sometimes prepared and presented on a specific Ad Hoc Subcommittee's topic or event.

Commissioner Zeidman and Vice Chair Amezola, the Members of the *Student Representative Position Development Ad Hoc Subcommittee*, provided a draft Pilot Program for selecting and appointing a student representative to the PRCS Commission at recent meetings (Attachment 2). The Commission may wish to continue discussing the draft Pilot Program. Chair Mohammed, a member of the *City Council Reports Ad Hoc Subcommittee*, gave a verbal report on the PRCS Commission's activities and concerns to the City Council at their January 27, 2020 meeting. Chair Mohammed may wish to comment on that report.
