BACKGROUND/DISCUSSION

During the fiscal year of 2021/2022, the EHRAC voted to hold various community events as part of their work plan. The Civil Discourse Workshop is one event the Committee approved. At the August 24, 2021 the EHRAC built consensus to agendize an action item to receive and discuss the Civil Discourse Workshop Ad Hoc Subcommittee's event program and details of the event, at the October 26, 2021 regular meeting.

During the October 26, 2021 regular meeting, the Civil Discourse Workshop Ad Hoc Subcommittee intends to recommend to the Committee to retain the services of the Institute for Civility in Government to facilitate a two-part Civil Discourse Workshop for the leaders and community stakeholders of Culver City.
