## **REORGANIZATION 2019**

### 1. Administration of the Oath of Office to the Reappointed Commission Member

#### **1-A. ADMINISTRATION OF THE OATH OF OFFICE**

On June 10, 2019, the City Council reappointed Scott Zeidman to PRCS Commission Seat Number 2 for a full term expiring June 30, 2023. To begin his new term, the Commission Secretary will administer the Constitutional and Loyalty Oaths to the reappointed Commissioner, both parties will sign a duplicate original of the document and Commissioner Zeidman will be presented with one of the signed documents.

### 2. Selection of the Chair and Vice Chair

At the first meeting at the beginning of the fiscal year, the PRCS Commission selects a Chair and Vice Chair. Commission does not have a formal policy for the selection of the Chair and Vice Chair. Traditionally the Vice Chair becomes the Chair and the Member with the most seniority becomes the Vice Chair. However, selection of Chair and Vice Chair is at the discretion of the Commission Members.

The current Chair announces that this is the time and place to receive nominations for Chair, calls for nominations, closes the nominations, and calls for the vote.
