## **BACKGROUND/DISCUSSION**

### **(1) Selection of the Chair and Vice Chair of the PRCS Commission**

Due to the December 2, 2020 resignation of former Parks, Recreation and Community Services Commission Chair Paula Amezola, the office of Chair is currently vacant. Traditionally the Vice Chair becomes the Chair and the Member with the most seniority becomes the Vice Chair. However, selection of Chair and Vice Chair is at the discretion of the Commission Members.

The current Vice Chair announces that this is the time and place to receive nominations for Chair, calls for nominations, closes the nominations, and calls for the motion.

**Recommended Motion:** That the Parks, Recreation and Community Services Commission select Commission Member \_\_\_\_\_ as Chair of the Parks, Recreation and Community Services Commission for the remainder of Fiscal Year 2020/2021.

#### **1B - NEW CHAIR OPENS NOMINATIONS FOR VICE CHAIR**

The new Chair then announces that this is the time and place to receive nominations for Vice Chair, calls for nominations, closes the nominations, and calls for the motion.

**Recommended Motion:** That the Parks, Recreation and Community Services Commission select Commission Member \_\_\_\_\_ as Vice Chair of the Parks, Recreation and Community Services Commission for the remainder of Fiscal Year 2020/2021.

### **(2) Appointment of PRCS Commission Members to City Committees**
