BACKGROUND / DISCUSSION

The 2024 Government Efficiency Ad Hoc Subcommittee was established to continue to implement the City Innovation Award Program to encourage employees and/or departments to contribute towards increased efficiency, improved quality of life for Culver City residents, reduced costs and/or generated revenue, or to demonstrate distinguished performance based on department goals/outcome measures. Applications for the City's Third Annual Innovation Awards were due on May 24, 2024. The Subcommittee received 12 applications.
