At the June 13, 2016 City Council meeting, the City Council made the following appointments to the Finance Advisory Committee:

• The City Council reappointed Crystal Alexander as Resident Member to Seat No. 1 of the Finance Advisory Committee for a term ending June 30, 2020.

- The City Council reappointed Alejandro Lara as Resident Member to Seat No. 2 of the Finance Advisory Committee for a term ending June 30, 2020.
- The City Council appointed Jose Casarez as Business Community Member to Seat No. 4 of the Finance Advisory Committee for a term ending June 30, 2020.
- The City Council appointed Gustavo Rendon as Business Community Member to Seat No. 5 of the Finance Advisory Committee for a term ending June 30, 2020.
- The City Council approved the recommendation of the FAC to extend the appointment of CCFFA member Bryan Sua to serve a second year as Staff Level Bargaining Group Appointee to Seat No. 7 through June 30, 2017.
- The City Council approved the recommendation of the FAC to extend the appointment of CCMG member Jane Leonard to serve a second year as Management Level Bargaining Group Appointee to Seat No. 8 through June 30, 2017.

City Charter Section 1401 provides: "Before entering upon the duties of their respective offices, all officers and employees of the City shall take and subscribe to the following oath or affirmation:

"I, [Member Name], do solemnly swear (or affirm) that I will support and defend the Constitution of the United States and the Constitution of the State of California against all enemies, foreign and domestic; that I will bear true faith and allegiance to the Constitution of the United States and the Constitution of the State of California; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties upon which I am about to enter."
