## BACKGROUND/DISCUSSION

At the May 2, 2018 regular Civil Service Commission (Commission) meeting, the Commission unanimously agreed to hear a closed disciplinary appeal hearing and directed staff to schedule a pre-hearing conference as outlined in Civil Service Rule 11. Due to the limited availability of the parties,

the Commission requested that staff also schedule hearing dates after the pre-hearing conference was confirmed.

The pre-hearing conference is scheduled and confirmed for Thursday, June 21, 2018 at 6:30 pm. At this time, there is a quorum of the Commission to move forward with the closed disciplinary appeal hearing on the following dates:
