BACKGROUND/DISCUSSION

Mid-Year Budget Monitoring Report

The attached Mid-Year Budget Monitoring Report (Mid-Year Report) presents the City Council with a snapshot of General Fund, Enterprise Funds and Internal Service Funds expenditures and revenues through the first half of Fiscal Year 2018/2019, which began on July 1, 2018. Special Revenue Funds are performing within expectations and are not a part of this report.

Notification Inviting Public Comment and Input

Consistent with the City Council's general policy, the City is committed to being open and transparent in all matters, especially those involving the collection and expenditure of public funds. In order to continue this commitment, the public is being provided this first of several opportunities to comment and offer input on the City's upcoming FY 2019/2020 proposed budget.

The City Manager's Proposed Budget for Fiscal Year 2019/2020 is scheduled to be formally presented to the City Council on Monday, May 13, 2019. Prior to this date, there will be additional public comment opportunities currently scheduled throughout the month of March, and opportunities during the period the City Council discusses the proposed budget with City staff in May and June.

FISCAL ANALYSIS

The Mid-Year Report provides detail into General Fund revenues received and expenditures disbursed through December 31, 2018, as well as adjusted projections through the end of the Fiscal Year (to June 30, 2019). General Fund expenditures through December 31, 2018 are \$65.6 million, or 53.4% of current revised budget projections. General Fund operating revenues through December 31, 2018 are \$43.2 million, or 36.2% of current revised budget projections. Total expenditures are estimated at \$127.4 million, \$0.5 less than the current budget.

Full year General Fund projections for Fiscal Year 2018/2019 show total estimated operating revenues at \$119.5 million, \$2.8 more than the current revised budget total. Increases in Property Tax and Charges for Services, along with various revenue sources within Licenses and Permits, contribute to the difference. Operating revenues are expected to meet or exceed operating expenditure requirements again for Fiscal Year 2019-20.
