BACKGROUND/DISCUSSION

Updates from PRCS Commission Representative Appointees

Staff has prepared this report as a standing Agenda Item to give the Commissioners an opportunity hear updates from their colleagues. The current list of Commission appointments, including meeting and contact information, is provided as Attachment 1.

PRCS Commission Ad Hoc Subcommittees

An "ad hoc" subcommittee serves only a limited or single purpose. It is not perpetual, and it is dissolved when its specific task is completed. The majority of the PRCS Commission's Ad Hoc Subcommittees were formed at the August 7, 2018 meeting. At the April 2, 2019 meeting, the Commission formed the "Human Relations Work Group Ad Hoc Subcommittee" and appointed Commissioners Amezola and Rickards as members (Attachment 1, page 2).

An Ad Hoc Subcommittee may be formed or dissolved at any Commission meeting, as long as the discussion has been placed on the Agenda in advance. Once an Ad Hoc Subcommittee has been created, updates are given by Members during the Standing Agenda Item, "Updates from the Parks, Recreation and Community Services Commission Ad Hoc Subcommittees and Representative Appointees to Outside Associations and City Committees." By consensus of the Commission, a separate Agenda Item is sometimes prepared and presented so that the full Commission can participate in discussions and decisions on an Ad Hoc Subcommittee's topic or event.
