### RECOMMENDATION

Staff recommends the City Council adopt an ordinance repealing and replacing Chapter 9.02, Sections 005-075 of Title 9 of the Culver City Municipal Code (CCMC) and adopt by reference the

2019 California Fire Code (CFC) with local amendments.

### **BACKGROUND/DISCUSSION**

At its meeting of October 14, 2019, the City Council (by a vote of 5-0) introduced, for first reading, an ordinance repealing and replacing CCMC Chapter 9.02, Sections 005-075 ("Fire Code Adoption and Amendments") and adopting by reference the 2019 CFC with local amendments. Accordingly, staff presents the Ordinance this evening for adoption, as introduced.
