- Josh Goldstein - Resident Member Seat No. 2 for a term ending June 30, 2024; and
- Kevin Lachoff - Business Member Seat No. 1 for a term ending June 30, 2022;

Additionally, the following appointment to the Finance Advisory Committee has been agendized for the July 13<sup>th</sup> Meeting of the City Council:

- Johnnie Griffing - Management Level Bargaining Group Member Seat No. 8

City Charter Section 1401 provides: “Before entering upon the duties of their respective offices, all officers and employees of the City shall take and subscribe to the following oath or affirmation:

“I, [Member Name], do solemnly swear (or affirm) that I will support and defend the Constitution of the United States and the Constitution of the State of California against all enemies, foreign and domestic; that I will bear true faith and allegiance to the Constitution of the United States and the Constitution of the State of California; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties upon which I am about to enter.”
