### RECOMMENDATION

### BACKGROUND/DISCUSSION

On January 27, 2020, City Council established the Equity and Human Relations Advisory Committee and adopted a resolution approving its bylaws to provide guidance on the EHRAC's purpose and objectives. On July 13, 2020 City Council approved amendments to the bylaws. The substantive changes included updating
