AUTHORITY

The Civil Service Commission has the authority to extend an eligible list in accordance with Civil Service Rule 7.5, as set forth below:

<u>7.5 Duration of Eligible Lists:</u> Each certified eligible list shall be valid for use for a period of one (1) year, unless exhausted sooner. The eligible list may be extended for up to one (1) additional year by Commission approval. The extended eligible list shall be valid until a new list is established for the same classification or the current Certification of Eligible List is exhausted, whichever occurs first, except as set forth below.

MOTION

- 2. Extend the Eligible List for Facilities Maintenance Worker,
- 3. Extend the Eligible List for Firefighter (Promotional),

- 6. Extend the Eligible List for Street Maintenance Crew Leader, and
- 7. Extend the Eligible List for Traffic Signal Technician.
