BACKGROUND/DISCUSSION

This item is carried forward from the last regular meeting of December 1, 2020. This item is to discuss potential changes to the EHRAC meeting date from the fourth Tuesday of the month to another day, based in part on the fact that the City's Committee on Homelessness also meets on the same evening. A desire has been expressed that the members of these two Committees may wish to attend each other's meetings.

Based on the days of the month when the City Council and other City Commissions, Boards and Committees hold their regular monthly meetings, the potential meeting dates are the second or third Tuesday of the month.

Additionally, Chair Rona obtained consensus to place an item on the agenda to discuss changing the Committee name, by removing the word "Advisory", or other possible name changes so the acronym is easier to pronounce and remember.

Changing the date of the regular meeting and changing the name of the Committee would necessitate a change in the EHRAC Bylaws, and City Council approval.
