### RECOMMENDATION

Staff recommends the City Council adopt an Ordinance repealing and replacing Chapter 15.03, *Construction in Flood Prone Areas* of the Culver City Municipal Code (CCMC), which incorporates changes that are required by the Federal Emergency Management Agency (FEMA) for the City's continued participation in the National Flood Insurance Program (Attachment 1).

## **BACKGROUND/DISCUSSION**

CCMC Chapter 15.03 is used to regulate development in flood prone areas by requiring that new or modified buildings (via the City Building Official) or structures in the public rights-of-way (via the Public Works Director/City Engineer) are flood resistant so that property damage is minimized during severe flooding events.

At its meeting of March 15, 2021, the City Council unanimously introduced the proposed Ordinance repealing and replacing CCMC Chapter 15.03, *Construction in Flood Prone Areas*, to incorporate changes required by FEMA for the City's continued participation in the National Flood Insurance Program, including, but not limited to, the addition of requirements for manufactured homes, recreational vehicles, attached/detached garages, and accessory dwelling units.

The proposed Ordinance is now presented for adoption.
