#### BACKGROUND/DISCUSSION

On July 7, 2020, the PRCS Commission reviewed and approved the list of PRCS Commission appointments, including those of the Ad Hoc Subcommittee Members. On April 6, 2021, the Commission appointed PRCS Commission Member Khary Cuffe as the *Alternate to the Community Development Block Grant (CDBG) Advisory Committee*. # PRCS Commission Ad Hoc Subcommittees

Once an Ad Hoc Subcommittee has been created, updates are typically given by Members during this Standing Agenda Item. By consensus of the Commission, a separate Agenda Item is sometimes prepared and presented on a specific Ad Hoc Subcommittee's topic or event.
