# 1. <u>Administration of the Oath of Office to the Reappointed Commission Member</u>

# 1-A. ADMINISTRATION OF THE OATH OF OFFICE

On June 14, 2021, the City Council reappointed Palvi Mohammed to PRCS Commission Seat Number 4 for a full-term expiring June 30, 2025. To begin his new term, the Commission Secretary will administer the Constitutional and Loyalty Oaths to the reappointed Commissioner, both parties will sign duplicate originals of the document after the meeting and Commissioner Mohammed retain one of the signed documents.

#### 2. <u>Selection of the Chair and Vice Chair</u>

At the first meeting at the beginning of the fiscal year, the PRCS Commission selects a Chair and Vice Chair. Commission does not have a formal policy for the selection of the Chair and Vice Chair. Traditionally the Vice Chair becomes the Chair and the Member with the most seniority becomes the Vice Chair. However, selection of Chair and Vice Chair is at the discretion of the Commission Members.

The current officers, Chair Kay Heineman and Vice Chair William Rickards, have served in their positions since January 5, 2021. They were elected after then Chair Paula Amezola resigned in December 2020. The City Clerk has confirmed that they may be re-elected to serve in Fiscal Year 2021/2022, should the Commission so desire.

The PRCS Commission Roster is provided as Attachment 1. The roster lists each Seat number with the associated Commission Member and their terms. Here is a summary of that information:

Seat Number 1: William Rickards - Second full-term expires on June 30, 2024.

Seat Number 2: Scott Zeidman - Second full-term expires on June 30, 2023.

Seat Number 3: Kay Heineman - Second full-term expires on June 30, 2022.

Seat Number 4: Palvi Mohammed - Second full-term expires on June 30, 2025.

Sear Number 5: Khary Cuffe - First full-term expires on June 30, 2024.
