RECOMMENDATION

Staff recommends that the Cultural Affairs Commission (CAC): (1) Dissolve the Ad Hoc 2021 Culver City Performing Arts Grant Program Subcommittee and the Creative Economy Report Subcommittee;

(2) Create the Ad Hoc 2022 Culver City Performing Arts Grants Program Subcommittee and Creative Economy Subcommittee; and (3) Assign Commissioners to Ad Hoc and Standing Subcommittees for Fiscal Year 2021-2022.

BACKGROUND/DISCUSSION:

At its first regular meeting in July of each year, the Cultural Affairs Commission typically reviews its subcommittees in light of the City Council adopted budget and work program for Cultural Affairs for the coming year, and two Commissioners are assigned to two or more of the CAC's subcommittees.

Subcommittee meetings are held on an as-needed basis, with some subcommittees meeting as frequently as every month and others only once or twice over the course of a year. In general, "ad hoc" subcommittees serve only a limited or single purpose, are not perpetual, and are dissolved when their specific task is completed. Ad hoc subcommittees do not constitute a "legislative body" and are not subject to the Brown Act. "Standing" subcommittees (e.g., the Public Art Subcommittee) have a continuing subject matter jurisdiction, are considered to be a "legislative body," and are subject to the Brown Act. These subcommittee meetings must be noticed and open to the public.

Proposed Action 1 - Dissolution of Ad Hoc Subcommittees

The 2021 Culver City Performing Arts Grant Program Subcommittee and the Creative Economy Report Subcommittee have completed their work and the Commission should now dissolve the subcommittees. Three of the four ad hoc subcommittees have not completed their work and they should not be dissolved at this time. To date, there has been no need to convene the Communications subcommittee since its formation and the Commission may choose to dissolve that subcommittee. Staff also recommends that going forward, the name of the foundation liaison subcommittee be adjusted to align with the revised name of the foundation (Culver City Arts Foundation).
