BACKGROUND/DISCUSSION

On June 22, 2021, Vice Chair Valverde made a motion to agendize this item. Vice Chair Valverde discussed the work on historical monuments by the Subcommittee and their discussions with the Culver City Historical Society. He raised the issue of expanding this Ad Hoc Subcommittee to look at possible monuments or art installations dedicated to ideas such as non-violence.

At the June 22, 2021 meeting, Chair Rona asked Vice Chair Valverde to give a small background about this Ad hoc Subcommittee and its purpose. Vice Chair Valverde discussed whether this Ad Hoc Subcommittee should only include historical ideas. The Ad Hoc Subcommittee could expand by adding additional members to look at other possible monuments that would include other ideas such as culture, education, dialogue, or something to that effect that are within the purview and workplan parameters of this Committee.
