RECOMMENDATION

Staff recommends that the Disability Advisory Committee (1) consider the nominations for an individual and/or organization for an "Outstanding Service to Persons with Disabilities" Commendation; and (2) select an individual and/or an organization to receive the Commendation from the City Council.

BACKGROUND

Each year, the City of Culver City proclaims October as Disability Awareness Month. The City Council and the Culver City Disability Advisory Committee (DAC) honor one outstanding individual and/or one organization as part of the Disability Awareness Month celebration. After open nominations, the DAC selects the honorees and the City Council issues formal Commendations at a public meeting.

Submissions for this year's Commendations opened on August 24, 2021. Nominations were made through the Parks, Recreation and Community Services Department's online form, by email or by mail. Community organizations who previously received Commendations include *Theater for the Blind* and *The Exceptional Children's Foundation*.

DISCUSSION

"Outstanding Service to Persons with Disabilities" Commendation Nomination Criteria

- Individual nominees of any age must be a resident of or work/volunteer in service of residents of Culver City
- Nominated Businesses or Organizations must be located in or serve residents of Culver City
- Written description of what the nominee is doing or has done to benefit individuals with disabilities in the past year(s)
- Statement of why the nominee should receive the recognition
- Nominee's name, address and telephone number
- Nominator's name, address and telephone number

Staff recommends that the DAC consider the nominations listed below and select by majority vote an individual and/or organization to receive a Commendation(s) during the Recognition portion of the October 11, 2021, City Council meeting.
