### RECOMMENDATION

Staff recommends the City Council (1) appoint members to the Civil Service Commission; Cultural Affairs Commission; Parks, Recreation, and Community Services Commission; Planning Commission; Board of Trustees of the Los Angeles County West Vector and Vector-Borne Disease Control District; Landlord-Tenant Mediation Board; Advisory Committee on Housing and Homelessness; Bicycle and Pedestrian Advisory Committee; Disability Advisory Committee; Equity and Human Relations Advisory Committee; Fiesta La Ballona Committee; Finance Advisory Committee; and LAX Area Advisory Committee; and (2) provide direction to the City Clerk regarding any vacancies not filled.

## **BACKGROUND**

In this application cycle, there are a total of 26 openings across 13 bodies as follows:

- Civil Service Commission (2 Positions Seat 1 and Seat 2)
- Cultural Affairs Commission (1 Position Seat 5)
- Parks, Recreation, and Community Services Commission (1 Position Seat 3)
- Planning Commission (1 Position Seat 5)
- Board of Trustees of the Los Angeles County West Vector and Vector-Borne Disease Control District (1 Position)
- Landlord-Tenant Mediation Board (3 Positions Tenant Seat 3, Landlord Seat 3, and Memberat-Large Seat 3)
- Advisory Committee on Housing and Homelessness (1 Position Seat 3)
- Bicycle and Pedestrian Advisory Committee (4 Positions 1 Resident Senior Citizen, 1 Resident, 1 Local Business Representative, 1 CCUSD High School Student)
- Equity And Human Relations Advisory Committee (1 Position Youth Rep Seat 1 and 1 Position - Labor Seat 1)
- Fiesta La Ballona Committee (3 Positions Seat 5, Seat 6, and Seat 7)
- Disability Advisory Committee (2 Positions Seat 1 and Seat 5)
- Finance Advisory Committee (2 Positions Seat 3 and Seat 6)
- LAX Area Advisory Committee (3 Positions)

Beginning on April 7, 2022, the City Clerk's Office publicized the vacancies as follows:

- Notice was posted on the City's website starting on April 7, 2022.
- Advertisements were published in the Culver City News on April 14 and May 5, 2022.
- Notice was sent via e-mail through *GovDelivery* on April 14, 28, and 30; and May 4, and 12, 2022.
- Notice was posted on the social media application NextDoor on April 14 and 28, and May 4, and 12, 2022.
- Notice was posted on social media applications Facebook, Instagram, and Twitter on April 14, 19; and 29; and May 6, 11, and 16, 2022.
- Notice was posted on Culver City TV beginning on April 25, 2022.

# **Confirmation of Eligibility Requirements**

Upon receipt, the City Clerk's Office reviewed each application to confirm whether, on the face of the application, applicant met the minimum eligibility requirements.

With respect to commission appointments, the Culver City Municipal Code (CCMC) provides certain general provisions related to members and those seeking appointment to Commissions. CCMC Section 3.03.005 provides in pertinent part:

"Commissioners shall be residents of the City, none of whom shall hold any paid office or employment in the City Government. Minors, age sixteen (16) or older, are eligible to apply with parental or legal guardian consent. No person may serve on more than one (1) Commission at the same time."

Please note, the Advisory Committee on Housing and Homelessness, Equity and Human Relations Advisory Committee, LAX Area Advisory Committee, and the Landlord seat for the Landlord Tenant Mediation Board do not require applicants to be Culver City residents.

The Bicycle and Pedestrian Advisory Committee and the LAX Area Advisory Committee do not have term limits.

Any seats not filled by the City Council this evening will be advertised again during the next annual cycle, unless City Council determines otherwise, and applications are accepted on a year-round basis.

#### **DISCUSSION:**

Following are summaries of those who submitted applications. Those applicants with one asterisk (\*) applied to multiple bodies. Those current appointees reapplying for their respective position will have "(Current Member)" next to their names, and those marked with a double up" symbol (^^) submitted applications after the May 16, 2022 5:00 PM deadline.

It should be noted that there were several applicants for bodies that require Culver City residency who did not meet this requirement. Those individuals received e-mails or phone calls from the City Clerk's Office indicating that they were not eligible for appointment.

#### Seat Vacancies:

Civil Service Commission (CSC) - There are two positions available Seat No. 1 and Seat No. 2. Seat No. 1 is available for a partial term expiring on June 30, 2023. The partial term would not be considered a full term, as it is less than two years, so the appointed member would be eligible for reappointment to a full term in 2023 and a second full term thereafter. Seat No. 1 was held by Robert Greenspan who resigned on April 1, 2022. Seat No. 2 is available for a full term expiring on June 30, 2026. Seat No. 2 is currently held by Commissioner John Kuechle who has served two full terms and, as per the Culver City Municipal Code § 3.03.015 (Term Limits), has reached his term limit.

Parks, Recreation, and Community Services Commission (PRCS) - There is one position available Seat No. 3 for a full-term through June 30, 2026 and is currently held by Commissioner Kay R. Heineman, who has served two full terms and, as per the Culver City Municipal Code § 3.03.015 (Term Limits), has reached his term limit.

**Planning Commission (Planning)** - There is one position available Seat No. for a full-term through June 30, 2026 and is currently held by Commissioner Dana Amy Sayles, who has served two full terms and, as per the Culver City Municipal Code § 3.03.015 (Term Limits), has reached his term limit.

**Board of Trustees of the Los Angeles County West Vector and Vector-Borne Disease Control District** - There is one position that is appointed to the outside body. Annual appointment is considered during the annual process for position which serves a January-December calendar year.

**Landlord Tenant Mediation Board (LTMB)** - Three seats are available for appointment to full terms. The Tenant 3, Landlord 3, and Member At-Large 3 seats are each for four years, expiring on June 30, 2026.

Tenant Members shall be tenants of residential rental property located within the City of Culver City, and neither the applicant nor the applicant's spouse or dependents shall have any financial interest in residential income-producing property in Culver City. Landlord Representatives shall either own, manage, or have residential income property interest within Culver City and preferably be residents of Culver City. Members At-Large shall be residents of Culver City and shall not be tenants nor shall they own or have an ownership interest in any residential income-producing property in Culver City.

<u>Tenant Seat No. 3</u>- One seat is available for appointment. This seat is currently held by member Julieanna Thompson has served two terms on the board, is eligible for re-appointment, and has applied to be considered for re-appointment for a four-year term ending on June 30, 2026.

## Bicycle and Pedestrian Advisory Committee (BPAC) - No Term Limits

A total of four positions are available - Resident Senior Citizen, Resident 3, Local Business Representative, and Culver City Unified School District (CCUSD) High School Student. The Resident Senior Citizen, Resident 3, and Local Business Representative are for two-year terms that expire on June 30, 2024, and the CCUSD High School Student is for a one-year term to expire on June 30, 2023.

Michelle Weiner (Resident Senior Citizen) who has been a member for 2 terms, and Travis Morgan (Resident 3) who has been a member for 1 full term, and George Montgomery (Local Business Representative) who has been a member for 2 terms are eligible for reappointment and have applied.

To be eligible, Resident positions must be residents of Culver City.

**Disability Advisory Committee (DAC)** - Seat Nos. 1, and 5 are available for appointments to full terms ending June 30, 2026. There are no term limits for the DAC and Seat No. 1 is currently held by Robyn Tenensap. Member Tenensap has served six terms, is eligible for re-appointment, and has applied to be considered for re-appointment. Seat number 5 is currently held by Member Dr. Jay Shery who did not reapply.

## Equity and Human Relations Advisory Committee (EHRAC) - One-year Term

There are two positions available: Youth Seat 1 and Labor Seat 1. The Youth Seat appointment is for a one-year term ending on June 30, 2023. The Labor seat is currently held by Anissa Di Vincente who has served one full term, is eligible for re-appointment, and has applied for re-appointment for a one-year term ending on June 30, 2023.

Members sit on this committee from November 1- October 31 of each year to allow for the same members to advise from the beginning of the planning through the wrap-up of the event.

## **Mandatory Training**

A mandatory AB 1234 Ethics and Brown Act training has been scheduled for appointees on Thursday, June 16, 2022. Training on diversity, equity and inclusion will also be scheduled. All new applicants must complete this training within one year of appointment.

## Commission, Board and Committee Interaction with the City Council

In accordance with City Council Policy 3002 *City Commissions, Board and Committees; Appointed Representatives to Outside Agencies and Boards (Attached)*, adopted by Resolution No: 2021-R040, all CBCs shall periodically report to City Council regarding their activities. Section V of the policy states:

"In an effort to facilitate regular communications between the City Council and its Commissions, joint meetings between the City Council and each of the Commissions shall be scheduled on an annual basis. Periodically, but no less than quarterly, each CBC shall submit to the City Council a written report on their respective activities. Nothing in this Policy shall preclude the City Council from requesting a report from any CBC at any time."

New Commission members will be informed of this requirement during their orientation.

#### FISCAL ANALYSIS

Costs for advertising the vacancies in the newspaper and on social media totaled approximately \$700. Future costs will include the following: Diversity, Equity, and Inclusion training for members may cost up to \$1,300, Sexual Harassment training may cost up to \$1,250, and new appointees to the Landlord-Tenant Mediation Board will need 30 hours of professional mediation training at a cost of up to \$625. Sufficient funding to support these costs has been included in the FY 2022-2023 Proposed Budget.
