#### BACKGROUND/DISCUSSION

In accordance with the Section VI. of the updated City Council Policy No. 3002 titled, *City Commissions, Boards and Committees; Appointed Representatives to Outside Agencies and Boards*, "[p]eriodically, but no less than biannually, each CBC shall submit to the City Council a written report on their respective activities."
